# From the President

Especially when you try to explain to your relatives and friends that it costs only \$96 per year...yes, per year...not per month. Guess what?? It can't. Yes, you read that right here. It can't. The original assessment was \$36 per year...45 YEARS AGO! The \$36 in 1970 would have to be \$218 now to keep up with inflation. But we do not have \$218 now. We enjoy a suppressed amount that is crippling us!

So what are we to do about this dilemma? We cannot remain financially viable at this rate. Some have suggested cost reductions. Done that! Some have expected the budget to be trimmed. Been there. Some have thought we should pursue delinquent accounts. Accomplished.

As president, I promised to provide a safe, enjoyable and well-maintained environment for us all to live in. To that end, I am requesting that the Board of Trustees gear up for another campaign to bring the maintenance assessment into line with current financial requirements. And we all should realize if we want to keep this corner of paradise viable and solvent, the maintenance assessment vote will have to bring back a resounding YES.

# VILLAGE ODDS & ENDS ...

**INJURED OR DEAD ANIMALS :** To report an injured or dead animal (deer, raccoon, etc.) and have it removed from a <u>state</u> culvert or <u>state</u> road, contact the **Arkansas Game & Fish Department** at 1-866-253-2506. (They'll need the street address of where the animal is located.) If you find a dead animal or **deer parts** on your property (left behind by illegal hunters), you may bury them but <u>NOT</u> burn them (according to the Dept. of Environmental Quality).

We've recently learned both the Benton County Roads Dept. and Sheriff's Dept. say they have no program in place for picking up dead deer from county roads or culverts. If the animal is lying in a culvert, notify the AR Dept of Environmental Quality at 1-888-233-0326.

**SPEED LIMIT in LBV:** The speed limit throughout the Village is only **20mph** and is enforceable by the Benton County Sheriff's dept. Please drive safely.

#### **BURNING ON YOUR OWN PROPERTY**

If you plan to do yard waste burning on your property you **must** get a burn permit beforehand from Benton County. (If you don't and a fire truck comes out because someone reports smoke at your property, you will be charged for the fire service call.) Call **Benton County at 1-866-207-5140.** Burn Ban info can be found on our website: www.lbvca.com. (**Burning of construction materials is prohibited.**)

#### VILLAGE ROADS:

Green and Blue street signs in the village are county roads. If you live on a road with potholes or lots of ruts, call Jeff Clark at the Benton County Roads (479-271-1052) to have it repaired. You do not need to call the Village Office or wait for a Board meeting to report it.

#### **CLEANING UP YOUR PROPERTY:**

**Please remember:** Be a good neighbor and rake out leaves and tree debris from your ditches and culverts to prevent water run-off problems, and either burn them or haul them away. If you hire someone to rake leaves or clear other yard waste from your property be sure to tell them to NOT push it into a ditch or culvert or into the street. You must take it to Inland Waste Service (479-878-1384) for disposal. You will be charged a clean-up fee if LBVCA has to clean out your ditch.

#### AIRSTRIP NEWS by Steve Bray



Lots of folks enjoy using the airfield for non-aviation activities such as walking, jogging, or bird watching. This is perfectly fine as long as you keep in mind that aircraft do use it as well. Please be aware that the use of headphones, ear-buds, etc., can make it difficult to detect approaching/departing aircraft especially coming over the lake with mo-

torboat sounds mixed in. The presence of a mountain at the end of the airfield forces pilots to abort landings quite early if they see people or animals on the runway, so please get clear immediately if you see an aircraft turning towards or lined up with the runway.

Over the next several months you may see work being done to fill the cracks in the runway surface. The pilots of LBVCA have donated towards the purchase of a crack filling melter/applicator machine and the materials to feed it. This is being funded by the pilots at no cost to the membership at large. The intent is to extend the life of the current pavement and defer the need for a future overlay and the associated expense. Many thanks to the pilots who made monetary contributions and are donating time and effort. I look forward to the upcoming "crack parties" at the airstrip.

If any additional pilots would benefit from making use of the pilot parking for ground vehicles, please contact Steve Bray for restrictions and permit. We would like to gauge the level of demand and make it available to other pilots on a space-available basis.

The bad news is that the pool inspector has informed us that it won't be too many years before the pool will fail opening inspection due to crumbling infrastructure. Mother Nature also didn't cooperate weather wise for the Memorial Day weekend, which was wet and chilly. The pool heater was the victim of a lightning strike which didn't help matters. By the time you read this a replacement heater should be in place and the water a bit less "invigorating".

Drinks and snacks are available for purchase at modest prices at the Rec Center. There is an "Honor System" drop box for when the Rec Center is unattended. The Rec Center contains a variety of weight and exercise machines, pool tables, air hockey, snooker, ping pong, and a Wii game system. LBV Buildings Receive Hail Damage

During the hailstorm that went through our area in late March, our buildings suffered some hail damage. Our insurance company along with a couple of roofing contractors all agreed that our roofs should be replaced. Our insurance company, The Cincinnati Insurance Company, indicated that we had 180 days to make a claim and we had two years from the date of loss to complete the repairs. We are now in the process of replacing the Community Center roof on Lodge Drive. The roofing contractor doing the work is Bill Duhaime, LLC. They have offices in Lowell.

The decision of the LBVCA Board was to defer replacing the roof of the Recreation Center on Dogwood Drive at this time. Our insurance is covering our total cost for the project so our Association will not be out any money.

# **BUILDING NEWS** From your Architectural Control Committee

In the past two months the ACC has approved applications for one new garage, one new home and two decks. One home application is pending Board waiver.

Benton county actually issues the permits (after approval from the ACC) and performs the inspections. When their inspectors are in LBV they observe any construction and look for posted permits. Construction being performed without a permit can results in a hefty fine, so it is always best to check with or advise the ACC before doing any type of construction; for example, replacing boards on an existing deck does not require a permit but expanding the footprint of an existing deck DOES.

One last item...when attending to your yard maintenance, please do not direct or discharge grass clippings, leaves, branches and the like into the streets and roadways. This not only becomes a road hazard, but it detracts from the beauty of our neighborhoods.
