Department Heads

Police Chief Barnett gave the Council a copy of his August activity report and also reported on the Swedish Fest coming up.

Fire Chief Connor reported to the Council about him finding 2 different pay scales for the Fire Department one from 2012 and the other from 2017. Chief Conner gave the Council a copy of the pay scales and a proposed EMT Pay-Plan Changes for the pay scale that was pasted by the Council in 2012.

Fire Chief Conner asked the Council about the \$9.37 call pay. Mayor Hight stated it would stay the same and that could be looked at before the next budget.

Terry Jackson reported the Garbage Truck is broke down.

Terry Jackson also reported the quotes he had received for the paving on Peterson and Pitt St. The quotes were for Labor and Equipment only. Town would get the material from the County Road Department.

Council Member Crumpton asked was it the same Company that paved Kristen Lane and if so they did not to a good job.

Mayor Hight said that they would bid it out.

Terry Jackson explained that the 1988 Dump Truck caught fire and is waiting on the Insurance Company.

Terry Jackson reported on a Limb truck he had found, it's a 2015 for \$98,295 and it would be in Alabaster Wednesday if anyone would like to go look at it.

Terry Jackson also reported the Skid Steer is also broken down.
