Student Sponsor Form

All applicants are required to have a sponsor and have the sponsorship form submitted during the time of application. We offer a 6 to 18 month residential counseling program. During that time, the student will have personal expenses that neither she nor The Father's Ranch will be able to meet. The following is a list of responsibilities The Father's Ranch Ministries requires the sponsor to assume on behalf of the student.

All payments (entrance fee, tuition, student's personal account, fees for optional activities, etc.) are the responsibility of the sponsor. All Required and Additional Fees are payable to The Father's Ranch Ministries, except for the Student's Personal Account (see details below).

Required Fees – Non-refundable unless otherwise noted

Fee	Amount	Due	Comments
Entrance Fee	\$500	Upon Arrival	Non refundable
Monthly Tuition	\$1,200	By the 1 st of each month	Prorated tuition will be offered only for the entry month at \$40 per day. The exit month is not prorated; it is paid in full. Tuition is non-refundable.
Student's Personal Account	\$50	By the 1 st of each month (Cash or Visa Gift Card mailed to the Student)	These funds are held in an account on behalf of the student. Funds that are not spent are refundable provided all other fees are paid in full.

Additional Fees (as needed or desired) – Non-refundable

Fee	Amount	Due	Comments
Medical Transportation Fee	\$25 or \$40	Each medical visit	The fee depends on the location of the doctor
Music Lessons	\$100	By the 1 st of each month	Piano, violin, or guitar
Nutritional Shakes	\$100	By the 1 st of each month	Only when medically necessary
School or GED Tutoring	\$300	By the 1 st of each month	TFR transportation fees and WA state testing fees also apply for GED studies
U.S.A. Tae Kwon Do	\$100	By the 1 st of each month	Additional fees may apply for clothing

For your convenience, payments to TFR may be paid via PayPal for an additional 3% (the "donate" button on our webpage links to PayPal).

Sponsor Responsibilities:

- 1) Pay all required fees. Also pay for all additional fees that apply to the student.
- 2) Pay for all medical expenses (directly to the medical provider).
- 3) Obtain the student’s prescription medications and mail them to the student on a timely basis.
- 4) Pay for the student’s medical insurance as required by law.
- 5) Provide transportation or travel fare for the student to arrive at TFR.
- 6) Provide return travel fare to original point of departure and be willing to aid in the student’s return to an appropriate living situation. Please understand that the student may quit or be asked to leave the program prematurely. If this occurs, plans for their return must be made immediately.
- 7) Provide encouragement through correspondence and/or phone calls.
