Based on the Associations bylaws, membership in ACC consists of ...

Regular Members: A California State Licensed Crematory proprietorship, partnership, corporation or society, operating and maintaining a crematory, a crematory columbarium, or crematory within a cemetery. There may be only three firms of the same ownership designated as regular members. Regular members may hold office on the Board of Directors and shall be entitled to vote

Regular Member Dues: \$395.00

Regular Member Affiliate: An affiliate member is an additional Regular Member firm of the same ownership, which is beyond the three member limit. An affiliate member is entitled to all the privileges of membership, except the right to hold office or vote.

Affiliate Member Dues \$300.00

Associate Member: An associate member is any licensed cemetery, mortuary, or society, engaged in the death care industry, who is interested in cremation. An associate member is entitled to some, but not all privileges of membership, except the right to hold office or vote.

Associate Member Dues \$250.00

California Crematory Operator: An operator member must be employed by a licensed California Crematory and must have received training in cremator operation as described in the 1993 Cremation Standards Act. A crematory operator member is entitled to some of the privileges of membership, but only one member is entitled to vote and hold a seat on the Board of Directors. He must be voted for this position by a majority of operator members.

Crematory Operator Dues: \$100.00

Cremated Remains Disposers: A Cremated Remains Disposer (CRD) members must be registered as such with the State and operate a licensed boat or airplane. A CRD member is entitled to some of the privileges of membership but may only vote or hold office in the CRD Division of the association.

Cremated Remains Disposer Dues \$250.00

Supplier Member: A supplier member consists of an organization or its authorized representatives, which sell products or services to crematories or funeral providers. A supplier member is entitled to all the privileges of membership, except the right to hold office or vote.

Supplier Dues \$125.00
