Advanced entries close January 8, 2022 at 5pm, at the secretary's home. If entry limits are not reached, day-of-trial entries will be accepted from 8 am to 8:30 am on Saturday and Sunday or until limits are reached. Refunds will be available for entries withdrawn prior to closing. Refunds for bitches in season will be given, minus a \$5.00 per trial administrative fee, if notification is given to the trial secretary prior to the start of judging.

Entries must be complete. Entries will not be accepted without a signature and/or correct fees. All entry forms must include the waiver on the back of the form. Express mail entries must include a signature permitting them to be left at the Event Secretary's address without a recipient signature.

START TIME/ RUNNING ORDER:

Judge's briefing will be at 8:45 AM both days. Judging starts at 9:00 AM.

Running order will be as follows:

(First round is trial 1, second round is trial 2)

Saturday: Beg, Beg, Exc, Exc, Int, Int

Sunday: Int, Int, Exc, Exc, Beg, Beg

Rosettes will be awarded for High In Trial, High Combined, and High Scoring Junior. Flat ribbons will be awarded for 1st through 4th places. New Title rosettes will be awarded for those teams achieving these accomplishments.

Site Information: The building will open at 7:30 am. The trial is indoors, on a fully matted single ring. Crating space is limited in the building. Ex-pens are not allowed.

ALL CRATES AND CHAIRS MUST BE ON MATS.

NOTE: For everyone's safety during the pandemic, masks are REQUIRED at all times while inside the building. Additional site and precautionary rules will be published in the final confirmation letter.

DIRECTIONS TO WWCDTC

From I-94 : Take I-94, Exit at #275, County F, Ixonia-Sullivan. (This is about 6 miles west of the Oconomowoc exit which is HWY 67.) Go North on County F about 4 miles. Go West on Elmwood Dr (County P) which is just before the train tracks. Go right on Cedar Drive. The building is at the end of the drive on the left.

From the East : Take Hwy 16 (to about 5 miles west of Oconomowoc). Go South on County F in Ixonia. Turn right on Elmwood (County P) which is right after the railroad tracks. Turn right on Cedar Drive. The building is at the end of the drive on the left.

- All UKC Performance events are open to any UKC registered dogs and dogs with a valid Performance Listing/Limited Privilege number, with the exception of Lure Coursing and Drag Racing. Please see the rules for each event regarding eligibility.
- We want you to keep the points earned at UKC Licensed events.**
Important things to remember:
 - Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at www.ukcdogs.com/tl-numbers. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
 - All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/Limited Privilege number.**
 - All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.
