Release from Liability

This AGREEMENT AND RELEASE FROM LIABILITY is entered into on this _____ Day of _____, in the year _____, by and between Lori Walker of Jump for Joy Equestrian Center, LLC and _____ (RIDER), and, if Rider is a minor, the parent/guardian of the Rider - _____. In exchange for use of property, facilities, and services of Lori Walker, the Rider, his/her heirs, assigns and legal representatives, hereby expressly agree to the following:

1. I agree that horseback riding and all equine activities are inherently dangerous activities AND that these activities expose me to above normal risks of bodily injury and/or death.
2. I agree that I am responsible for my own safety while engaging in any and all equine activities on the owner's property and/or adjoining property of others, which have given me permission to ride and use for equine activities.
3. I agree to acknowledge all of the owner's rules and regulations pertaining to any and all equine activities occurring on the owner's property and on any other property while participating in said equine activities.
4. I agree that I am responsible for wearing protective head gear and appropriate protective boots as deemed suitable for equine activities while engaging in equine activities for the purpose of Rider safety.
5. I agree that the Owner, Lori Walker, Owner's employees, the stable, its agents, volunteers, and adjoining property owner's are NOT liable for any injury to or the death of Rider and/or participant in equine activities resulting from the inherent risks of equine activities.
6. I understand the risks involved in equine activities and I AGREE TO ASSUME ANY AND ALL RISKS INVOLVED IN RIDER'S USE OF OR PRESENCE UPON OWNER'S PROPERTY AND FACILITIES while engaging in any equine activity without limitation and including the risk of death, bodily injury, property damage, falls, kicks, bites, unavailability of emergency medical care, and/ or the ordinary negligence or the deliberate act of another person.
7. Rider and Rider's parent or Guardian agree to assume full responsibility for full insurance coverage on Rider and riders property.
8. I am aware of the North Carolina Equine Liability law which protects equine facilities and understand that (cont. on page 2)

8. (continued from page 1) I will not sue or attempt to sue the Owner, Lori Walker, agents volunteers, employees in association with any claims, damages, costs, or expenses arising from riders use of or presence upon Owner's property while engaging in any and all equine activities including those based on death, bodily injury, and property damage.

9. Rider and Rider's parents or guardian, (if Rider is a minor) agree that this agreement and release of liability is a contract that when signed by the parties involved will be legally binding to all parties, subject to the above terms and conditions and shall be enforced and interpreted under the laws of the state of North Carolina.
