<u>Discuss proposed creation of Multiple Dwelling Unit (MDU) rates for water and sewer</u> The board discussed the proposed rates. The board directed staff to prepare and present rate options for the entire water system at a future meeting.

<u>Lake/Snow report</u> The lake has 1808 AF in storage. The snow – water equivalent is at 76 percent of average and the ytd precipitation is at 72 percent of average. Soil moisture is at 55 percent saturation. A failure of the Chapman PRV failed and caused the irrigation system to be shut down for the past two days.

<u>Committee report</u> The water and sewer committee met earlier in the day and discussed rates, the interconnect project bidding process, and the purchase of a truck.
