Regular Meeting ----- September 5, 1989

The meeting was called to order by the Chairman, D. L. Taylor at 7:00 A.M. at the District office. Other Board members present were Gary Wilson and John Groo. ATTENDANCE

Special Service District members present were D. L. Taylor, Gary Wilson, George White and Bill McDougald.

Others present were Ferne Mullen, Dale Pierson and Roberta Highland.

Roberta read the minutes of the meeting of August 15, 1989. After calling for corrections or additions, and hearing none, the Chair declared the minutes approved as read. MINUTES

D. L. asked about the double connections and Dale replied there are rumours that some people have put in their own connections that are not metered. He followed the tips he was given but found nothing. Gary stated he knows of a person who tells people there are extra connections out there but will not say who and Wilson thinks the rumours are pretty well unfounded. IRRIGATION CONNECTIONS

Dale reported the Division of Water Resources are meeting on September 8, 1989 to act on our request to reschedule the Special Service District Bond. The Board reviewed the schedules and D. L. asked who could attend the meeting in Bicknell on the 8th and stated he could go. RESCHEDULING BOND PAYMENTS -GSSWD

Cloud seeding participation was discussed and it was agreed to get more information and participate if possible. CLOUD SEEDING

Dale asked for discussion of the feasibility of hiring another employee. Dave Cozzens seems to be hesitant about becoming an employee. The staff feels what would be most necessary is a general maintenance man and only then on a part time basis to be shared with the Spanish Valley District. Mobile radio was discussed and Gary suggested if we go that route to buy our system. Using the City frequency was also discussed. Gary suggested budgeting a thousand or so dollars next year and investigate our options. Gary will get some estimates and report back. POSSIBLE 4TH EMPLOYEE MOBILE RADIO

D. L. reported the negotiations with Robertson for the Chapman well is ongoing, and Gary reported that at the previous meeting the District authorized 60 water and sewer connections for the property surrounding the well, a tank site, the water rights and a right of way, and the County RON ROBERTSON WELL (Chapman)

would put in a gravel road. Robertson would like 120 water and sewer connections, transferrable to the rest of the valley in which Ron would participate in one-half of the costs of installation of connections and would lease the water rights to the District. The possibility of only acquiring the property, and using District's water right and letting Ron keep his rights was discussed. The possibility of Ron keeping his right and drilling another well near George White Well #4 was touched upon. George stated he felt the District should apply for a right and drill another well with enough elevation so that we could serve the upper valley. George suggested we transfer a right and drill a test hole. Gary suggested we go back to Ron with a reasonable offer for the well site because we know water is there. Test wells were discussed, and Gary suggested the District offer 60 water and/or sewer connections, and the Road to the site in exchange for the well & tank site and water right. D. L. suggested if he threw in the rights remaining on City Well #10, we could offer 100 connections. It was also suggested we file for a culinary right as soon as possible. It was agreed to meet with the Spanish Valley Water & Sewer Improvement District and discuss these options.

ROBERTSON
WELL (Cont.)

Dale reported we still have some pressure problems in the Chapman Lane area. He has moved Carmichael to the schedule with the lower valley. He is considering changing the demand to a 2 day schedule over 8 days and shut down the Beeman Well. Changing the rate charged the customers was briefly discussed, and it was agreed not to change the rate at this time.
