### OPERATION SAVE

Supportive Services for Veteran Families (SSVF) is a grant that assists veterans and/or veteran families to maintain stable housing or rehouse homeless veterans and/or veteran families. The SSVF Grant under ARCH that is known as Operation SAVE serves 8 counties in Northeast Tennessee: Carter, Greene, Hancock, Hawkins, Johnson, Sullivan, Washington, Unicoi, and 10 counties in Southwest Virginia: City of Bristol, City of Norton, Buchanan, Dickenson, Lee, Russell, Scott, Tazewell,

Washington, Wise (see map below).

# OPERATION SAVE (SSVF GRANT)

The two main purposes of the SSVF grant is to



1) To promote housing stability among very lowincome Veteran families who reside in or are transitioning to permanent housing. 2)

SSVF is a short term crisis response case management intensive program used to address immediate housing needs and secure community supportive services for the veteran.

ARCH offers the following services through the SSVF grant:

- Storage and/or moving expenses
- First month's rent
- Rent deposits
- Utility deposits
- Car repair
- Child care
- Assistance with public transportation -Public buses
- Employment related expenses
  - -Employment related clothing
  - -Uniforms
  - -Tools related to employment
  - -Certifications
  - -Driver's License/state ID

NOTE: These services are based on veteran eligibility

### Oualifications:

IMPORTANT: Must provide a copy of DD214 unless the client is HUD VASH for consideration for services.

- A veteran must have an Honorable or OTH Discharge and have at least 24 hours of active duty before the veteran or their family is eligible for SSVF services.
- Note: the Veteran identifies the members of his/her household. A family may include persons who are not related by blood or marriage.

Household gross annual income cannot exceed 50% of area median income based on the income limits set by HUD for each county.
