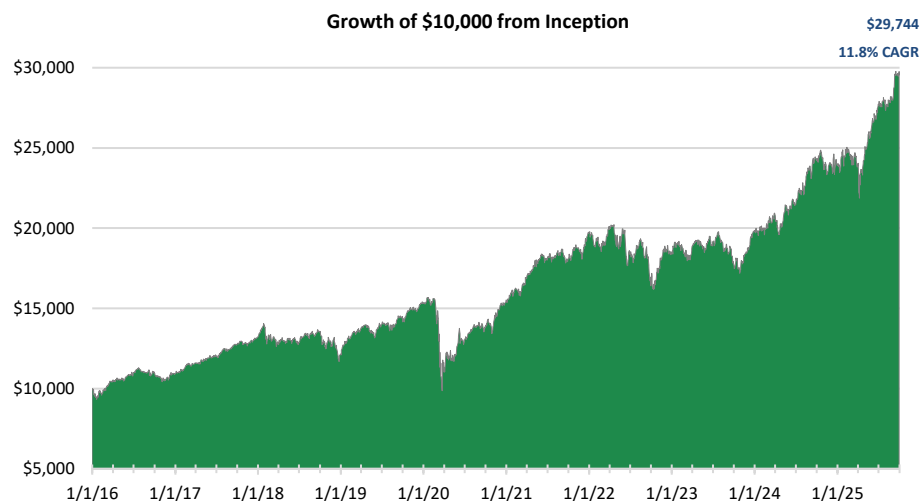

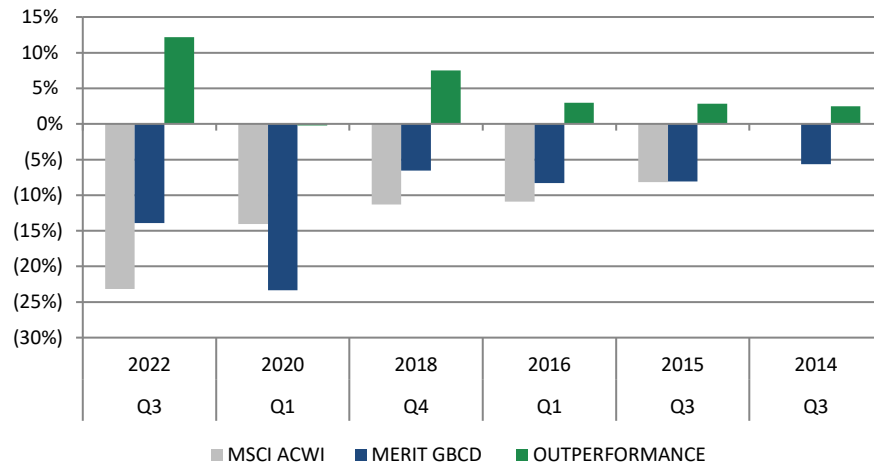

ILLUSTRATIVE HISTORICAL PERFORMANCE

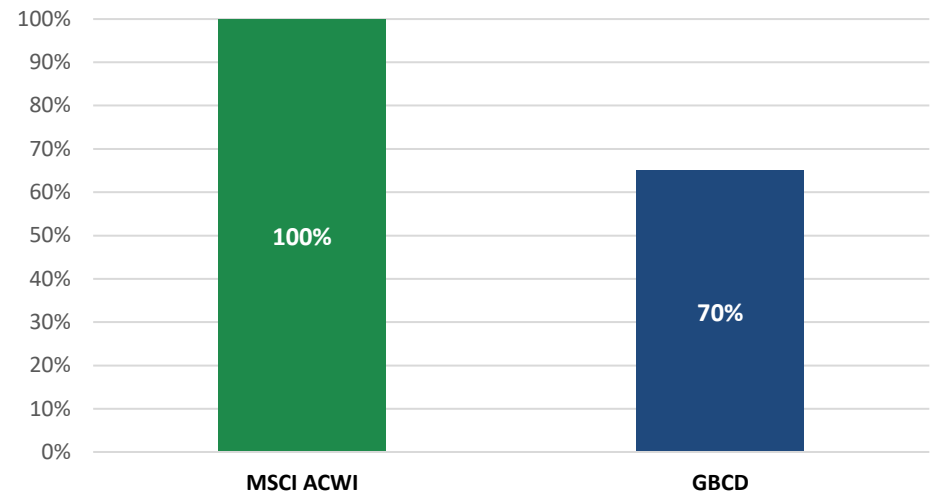

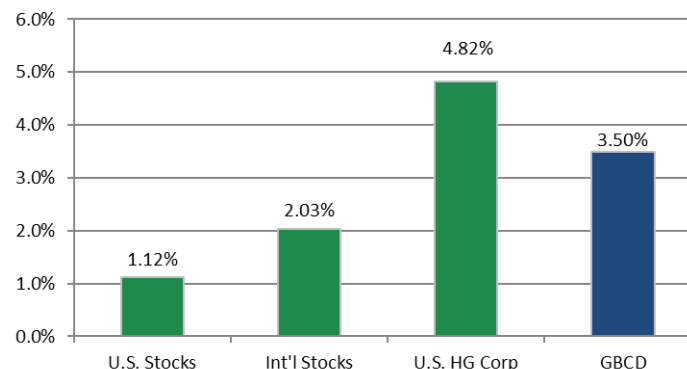
DIVIDEND YIELD & RISK METRICS

DIVIDEND METRICS

- Solid dividend yields across all sectors ranging from 1.6% to 8.9%
- High dividend income with equity upside provides inflation hedge

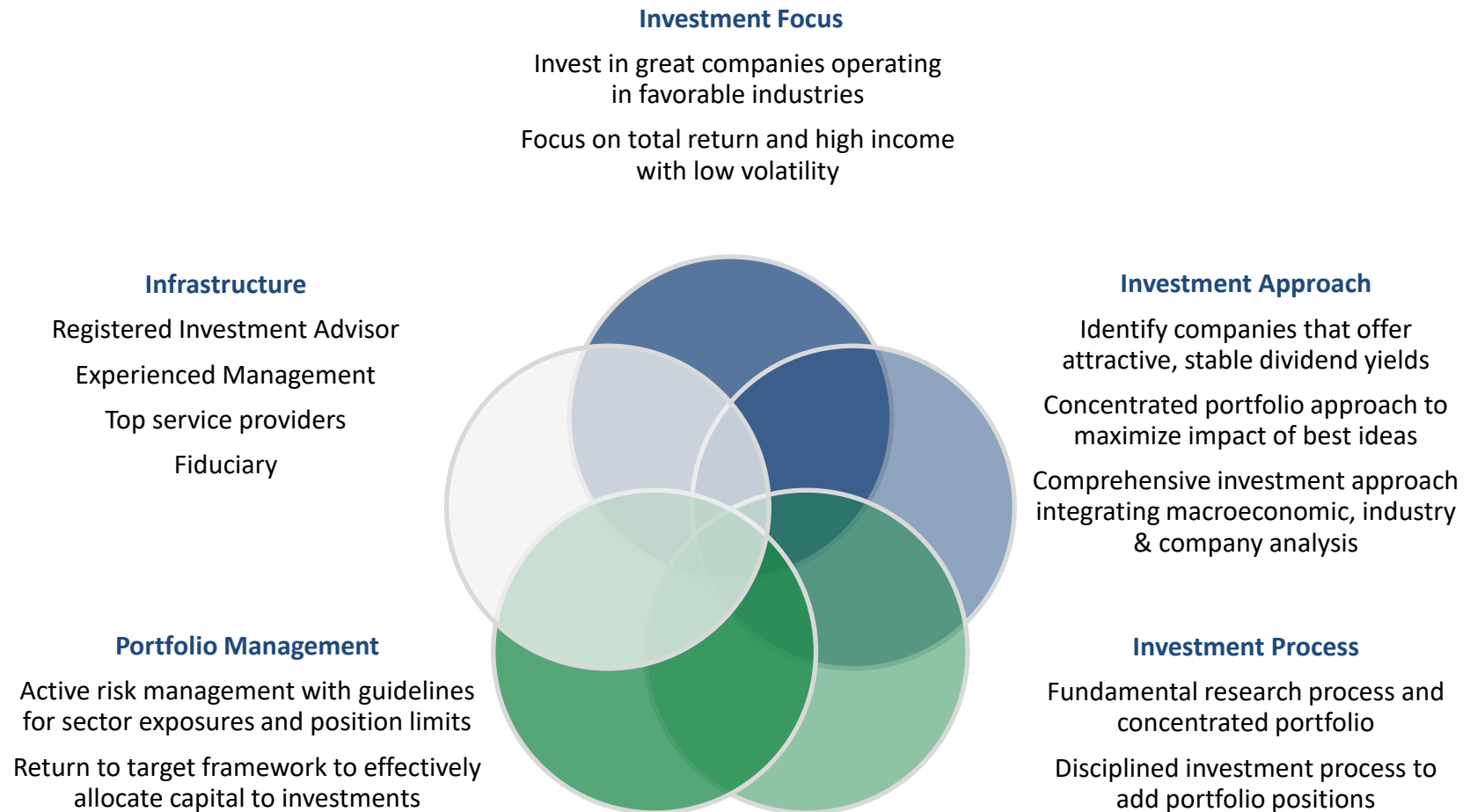
