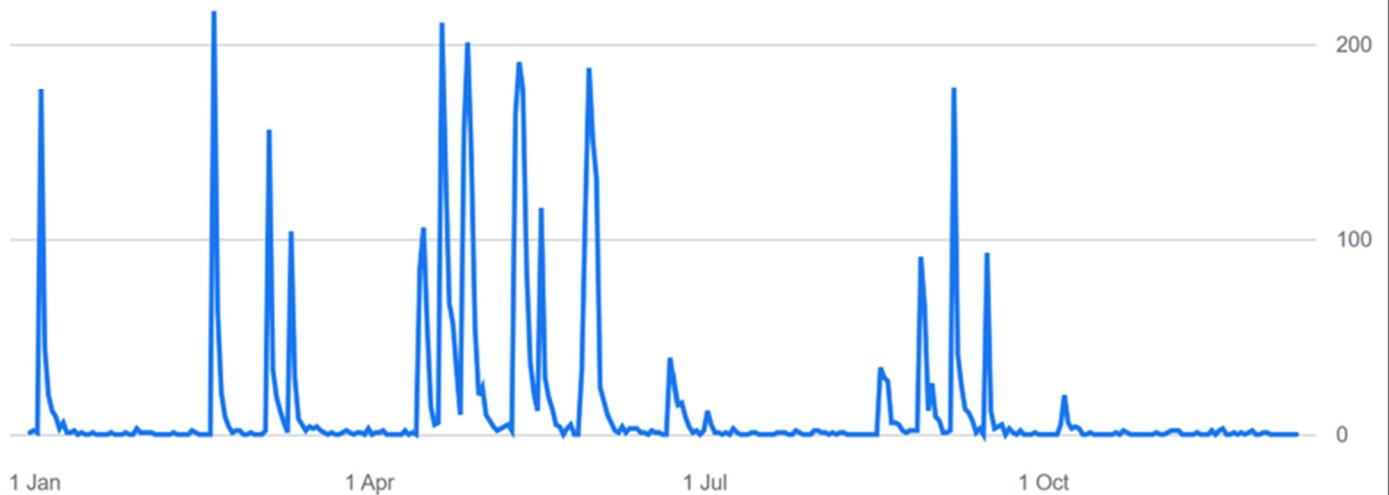
Jasmine Evans is now a co-administrator for our Facebook page.
