# **Compliance Inspections**

Please note that <u>compliance inspections are still being conducted</u> and when necessary courtesy or violation letters are being mailed out. Please take time to look over your property for any issues you might have. Most violations are for issues that are easy to correct. The appearance of our neighborhood directly affects the property values of your home and those around you.

# **Compliance Summary**

From January through July this year there have been 928 Courtesy letters issued. 338 Of those resulted in Formal letters being sent. That is done when an infraction of the CC&R's is not corrected within 30 Days. As a result of the 155 hearings conducted and including those with previously fined 160 properties are in fining status. The purpose of fines is to encourage owners to comply with our rules. Those owners who choose not to follow the rules have a negative impact on the rest of us.
