## CAPITULATION TO GLOBALIST AGENDAS

*Citizen Restrictions and Civil Rights Withdrawn*

The purpose of this article is to document a very important question posed by a Canadian Parliamentarian concerning 'Internment Camps' to be operated in every Province of Canada. The pretext is the pandemic that is scaring the masses into compliance or face 'Relocation Centers'. It is part of a plan to house the 'Dissenters' or those refusing the New Economic Reset. This term is now the code word for the New World Order. The question was posed by Randy Hillier, a rural activist and politician in Ontario, Canada. He was most recently elected as a Progressive Conservative MPP for Lanark-Frontenac-Kingston during the 2018 Ontario General Election.

According to public record, Hillier is a Licensed Construction Electrician with a diploma in Electrical Engineering Technology from Algonquin College. He lives near Perth, Ontario, Canada. Hillier has formerly served as the PC critic for the Attorney General, Labor Party, Northern Development, and Mines and Forestry in the Provincial Legislature. In 2003, Hillier co-founded and served as the 1<sup>st</sup> President of the Lanark Landowners' Association. In 2006, he became the 1<sup>st</sup> President of the 15,000-member Ontario Landowners Association (OLA). The OLA was formed to preserve and protect the rights of property owners guaranteed within the Constitution of Canada and the laws of the Province of Ontario.

Under Hillier's leadership, the Landowners' groups initially engaged in acts of civil disobedience, including blocking highways, barricading government offices, staging illegal deer hunts, and publicly breaking laws that the Landowners regarded as unjust. This was primarily done as a tactic to draw media attention to perceived injustices, and thereby to pressure the provincial government to amend the laws or at least enforce them in a manner less injurious to the interests of rural Landowners. Recently, Hillier took part in a rally protesting the COVID-19 lockdown measures in Ontario at Queen's Park. The following is the excerpt of the question Hillier posed to the Ontario Parliament addressed to the Canadian Premier about the Detention Centers planned for containing Canadians. And detentions are not limited to those who refuse of the coming vaccine.

*'My question is to the Premier. In my supplemental question, yesterday I asked this Government if the People of Ontario should prepare for Internment Camps? In September, the Federal Government posted a call for expressions of interest for contractors to supply, provide and manage Quarantine Isolation Camps throughout every Province and every Territory in Canada. These Quarantine Isolation Camps however are not limited to people with COVID but provide a wide latitude for many people to be detained.'*

*Surely this government is aware of the intentions to build these Isolation Camps from coast to coast. And my question to the Premier is how many of these Camps will be built and how many people does this Government expect? To question back to the Premier, here is the RFP. And in the RFP, it uses clear language to express that these Camps can be used for a broad spectrum of people not limited to travelers. Indeed, it does not even mention international travelers.*

*It is just a broad latitude of people. And I will send over the copy of the RFP after. So, your Government is... must be in negotiations and aware of these plans to potentially detain and isolate Citizens and Residents of our country, in our Province. So, Speaker, to the Premier, where will these Camps be built how many people will be detained and for what reason? For what reasons can people be kept in these Isolation Camps and I would like to have the Premiere assure the people of remember... Take a seat. The next question.*

A member of the Canadian ruling party responded but gave a shallow and evasive answer. There was no allowance for a rebuttal or debate. It should be noted that this Canadian MPP, Hillier has sought Church help to disseminate information that challenges the accepted 'science' and official narrative of the government about COVID. Hillier has met with various Church Leaders in Perth, Ontario. Hillier has stressed, that at this time, the various municipalities do not have the authority to enforce any mask-wearing aside from threats and fines. He stresses that some of the medical data on COVID-19 that is contrary to the official narrative is not being reported by the mainstream media. This is data that would challenge the accepted science about the efficacy of masks and those who have actually died of the virus exclusively.

It is noted that the official data points are just being used to instill fear among the populations to have them comply to any governmental mandate. Pertaining specifically to Churches, it was noted that in countries like Canada, many congregations that have had their services outdoors would not be able to due to the colder weather conditions of the Fall and Winter months. And perhaps this is the plan all along. What is occurring now not only in Canada, but around the world is a forced and radical transformation of Humanity. Societies are being radically changed and altered in every aspect of life. Why? Some people want a violent revolution to get things done. What is occurring instead is a medical and supposed scientific one.

According to Klaus Schwab, 'Mr. New World Order', the coming World Economic Reset is predicated on having to be a 'Macro Reset'. This is to mean that the gradual 'Micro' changes that have occurred naturally in society and Nations is not enough now. The New World Order demands and will require a radical, revolutionary catharsis and that is what is presently being carried out. It is really the implementation of the U.N. Agenda 2020-30. The following is the description of another Canadian insider who corroborates with the MPP Hellier of what the government of Canada is doing. The article is being circulated online, on non-mainstream news outlets, mainly online websites. The following is the message italicized with certain words or phrases colorized for emphasis.

*'I want to provide you some very important information. I am a committee member within the Liberal Party of Canada. I sit within several committee groups but the information I am providing is originating from the Strategic Planning Committee (which is steered by the PMO).*

*I need to start off by saying that I am not happy doing this, but I have to. As a Canadian and more importantly as a parent who wants a better future not only for my children but for other children as well. The other reason I am doing this is because roughly 30% of the committee members are not pleased with the direction this will take Canada, but our opinions have been ignored and they plan on moving forward toward their goals. They have also made it very clear that nothing will stop the planned outcomes. The road map and aim were set out by the PMO and is as follows:*

- Phase in secondary lockdown restrictions on a rolling basis, starting with major metropolitan areas first and expanding outward. Expected by November 2020.*
- Rush the acquisition of (or construction of) Isolation Facilities across every Province and territory. Expected by December 2020.*
- Daily new cases of COVID-19 will surge beyond capacity of testing, including increases in COVID related deaths following the same growth curves. Expected by end of November 2020.*
- Complete and total secondary lockdown (much stricter than the first and second rolling phase restrictions). Expected by end of December 2020 - early January 2021*
- Reform and expansion of the unemployment program to be transitioned into the Universal Basic Income program. Expected by Q1 2021.*
- Projected COVID-19 mutation and/or co-infection with secondary virus (referred to as COVID-21) leading to a 3<sup>rd</sup> wave with much higher mortality rate and higher rate of infection. Expected by February 2021.*
- Daily new cases of COVID-21 hospitalizations and COVID-19 and COVID-21 related deaths will exceed medical care facilities capacity. Expected Q1 - Q2 2021.*
- Enhanced lockdown restrictions (referred to as 3<sup>rd</sup> Lock Down) will be implemented. Full travel restrictions will be imposed (including inter-province and inter-city). Expected Q2 2021.*
- Transitioning of individuals into the Universal basic Income program. Mid Q2 2021.*

- *Projected supply chain break downs, inventory shortages, large economic instability. Expected late Q2 2021.*

- *Deployment of Military Personnel into major metropolitan areas as well as all major roadways to establish Travel Checkpoints. Restrict travel and movement. Provide logistical support to the area. Expected by Q3 2021.*

*Along with that provided road map, the Strategic Planning Committee was asked to design an effective way of transitioning Canadians to meet an unprecedented economic endeavor. One that would change the face of Canada and forever alter the lives of Canadians. What we were told was that in order to offset what was essentially an economic collapse on an international scale, that the Federal Government was going to offer Canadians a total debt relief.*

*This is how it works: the Federal Government will offer to eliminate all personal debts (mortgages, loans, credit cards, etc.) which all funding will be provided to Canada by the IMF under what will become known as the World Debt Reset program. In exchange for acceptance of this total debt forgiveness the individual would forfeit ownership of any and all property and assets forever. The individual would also have to agree to partake in the COVID-19 and COVID-21 vaccination schedule, which would provide the individual with unrestricted travel and unrestricted living even under a full lock down (through the use of photo identification referred to as Canada's HealthPass).*

*Committee members asked who would become the owner of the forfeited property and assets in that scenario and what would happen to lenders or financial institutions, we were simply told the World Debt Reset program will handle all of the details. Several committee members also questioned what would happen to individuals if they refused to participate in the World Debt Reset program, or the HealthPass, or the vaccination schedule, and the answer we got was very troubling. Essentially, we were told it was our duty to make sure we came up with a plan to ensure that would never happen.*

*We were told it was in the individual's best interest to participate. When several committee members pushed relentlessly to get an answer, we were told that those who refused would first live under the lockdown restrictions indefinitely. And that over a short period of time as more Canadians transitioned into the debt forgiveness program, the ones who refused to participate would be deemed a public safety risk and would be relocated into Isolation facilities.*

*Once in those facilities they would be given two options, participate in the debt forgiveness program and be released, or stay indefinitely in the isolation facility under the classification of a Serious Public Health Risk and have all their assets seized. So, as you can imagine after hearing all of this it turned into quite the heated discussion and escalated beyond anything I've ever witnessed before. In the end it was implied by the PMO that the whole agenda will move forward no matter who agrees.'*

If all the above is true, one can sense that the Globalists have revealed their game plan as not only to be implemented in Canada, but throughout the world. The USA already has such 'Detention Centers' or those nefarious FEMA Camps and/or abandoned Walmart malls.
