A Project Reservation Agreement can also be printed on our website by clicking on "Get Started" from the webpage for the brochure you are selecting. Many of our food brochures include all non-frozen/shelf-stable items which can be shipped throughout the continental U.S. Unipak frozen food fundraisers may not be available in some areas of AZ, CA, CO, ID, MN, MT, NE, NM, NV, OR, SD, TX, UT, WA, WY. Contact us to confirm availability in your area. Shelf-stable fundraisers are available throughout the U.S.

You'll receive your brochures in about 7 days, and we'll include the information for your online sales. Brochures are free but we require no cancellation once an agreement is submitted. Be certain you are approved to hold the fundraiser and that your organization has agreed to fundraise with the brochure you have selected.

Distribute brochures to your sellers and determine how long you will continue your sales. (We recommend two weekends for 2-3 weeks) Customer checks, if accepted, are made payable to your organization.

Collect all brochures and payments at the end of your selling period. An order requires a minimum of just 100 items. There are no case requirements accept for pies. Order only what you sell. 1-page brochure orders can be submitted as a bulk order when ordered in cases instead of the standard packed-by-seller.

Your organization will earn 40% Profit on brochures sales, online sales, and direct ship to home sales. Shipping is free unless the combined brochure sales and online sales shipped to the organization sales are less than 400 items. There is a \$1.00 / item charge below 400 items sold. Example: If your organization has 300 items sold there will be a \$100 fee. Sales with less than 100 items may be canceled at the discretion of UNIPAK Supply.

Mail your order forms back to the company. A shipping label will be provided for returning your order forms. Once your order forms have been received and data entry has been completed, you'll receive an invoice for the amount due along with reports for your online sales. You'll keep your profit upfront and if opted to offer online sales your profit will be credited on your brochure sales invoice.

Pay for your purchase. We accept a school/organization check, cashier's check, or a money order. Credit Cards are accepted and will incur a credit card fee. Purchase orders are accepted for public schools with a 15-day payment agreement.

Shipping/Holiday Deadlines. In the off-season, orders can take 3-4 weeks to ship, 5-6 weeks for orders placed in Oct/Nov. Beat the rush and fundraise early fall! For Thanksgiving delivery, order forms must be received by Oct 16th and for Christmas, by Nov 13th. Online orders shipped to home ship immediately. Online only, single page fundraisers shipped bulk to your organization can close Oct 30th for Thanksgiving delivery and Nov 21st for Christmas delivery. With frozen foods, the shipping company will assign a delivery date and time to a school or business address. Residential address/athletic field delivery is not available.

Report any missing or broken items. Seldom are there any missing or damaged items with our shipments. However, should any replacements be required, we will process a new order for you. Please notify us within 72 hours.

We'll provide coaching to help your campaign succeed, extended office hours Mon-Sun 9 am - 9 pm EST, and a solid commitment to process your order and any required replacements. When you require assistance, we'll be available to help you!
