

ORDINANCE NO. 1
 SERIES OF 197 4

AN ORDINANCE MAKING ANNUAL APPROPRIATIONS OF MONIES AND FUNDS TO COVER EXPENDITURES TO BE MADE BY THE TOWN OF MARBLE, COLORADO, AS PROVIDED BY IT'S BUDGET FOR THE FISCAL YEAR JANUARY 1, 1974 THROUGH DECEMBER 31, 1974 INCLUSIVE.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MARBLE, COLORADO:

Section I. This ordinance shall be known and termed as the Annual Appropriation Ordinance for the Town of Marble, Colorado, for the fiscal year beginning on the first day of January, 1974, and ending the thirty-first day of December, 1974, inclusive.

Section II. That the sums of amounts of money hereinafter set out are deemed necessary to defray the expenses and liabilities of said Town during the fiscal year. That the revenue to be collected by said Town during the said fiscal year, together with funds not expended in previous years, is hereby appropriated to defray all necessary expenses and liabilities of said Town and that said appropriation is hereby made for the objects, purposes and in respective amounts as follows:

Section III. That the budget for the Town of Marble, Colorado is set at \$29,589.00 and such amount is hereby appropriated for Fiscal Year beginning January 1, 1974 and ending December 31, 1974.

Section IV. That all unexpended balances remaining to the credit of any appropriation herein made, after all bills and accounts have been paid, shall revert to and be transferred to the operation reserve of the General and Water Funds.

Section V. That all funds of the Town are declared available to meet the budget for the Town of Marble for the Fiscal Year beginning January 1, 1974 and money may be transferred for the General Fund to the Water fund as and when such transfer becomes necessary to meet the budget.
