Join us for a day of skiing or boarding for the entire family at nearby Spring Mountain, located at 757 Spring Mount Road, Spring Mount, PA 19478 | 610-287-7900.

Cost: (Fees are valid if paid in full by Friday, January 16th at 7 PM. After that time add \$15 per person to amounts below. NO registrations accepted after 7 PM on Friday, January 23rd)

For Scouts and other youth ("Youth" is age 17 and under):

\$45 for restricted lift ticket, ski or board lesson, helmet rental and ski or board rental (an awesome deal!)

\$50 for all-area lift ticket, helmet rental and ski or board rental (What? Yes – that's right!)

\$25 for all-area lift ticket only (oh my goodness!) **Must have your own helmet and skis or snowboard**

For adults (18 and older):

\$91 for restricted lift ticket, ski or board lesson, helmet rental and ski or board rental

\$86 for all-area lift ticket, helmet rental and ski or board rental

\$47 for all-area lift ticket only (must have your own helmet and skis or snowboard)

ALL PARTICIPANTS MUST USE A HELMET – NO EXCEPTIONS.

Departure/Transportation:

For those taking the Troop bus: Arrive at the cabin no later than 7:30 AM on Sunday, January 25th. **SPACE ON THE BUS IS LIMITED. SCOUTS GET PREFERENCE OVER NON-LEADER ADULTS AND OTHER ATTENDEES BUT OTHER ATTENDEES ARE WELCOME ON THE BUS ON A "SPACE-AVAILABLE" BASIS.**

For families driving right to Spring Mountain: Leave your home in time to meet the Troop at Spring Mountain **at 8:30 AM SHARP** so you can get your rental and lift ticket

Bus Return: 4:30 PM to Cabin (approximate – boys will call when 30 minutes from cabin)

How to sign up for the ski trip:

Either bring your payment and completed form to the January 16th meeting, or get your payment and completed form to Jim Bennett at his home (1116 Signal Hill Lane, Berwyn PA, 19312) so that Mr. Bennett receives it by ***no later than 7 PM on January 23rd***.

Sign-ups after January 16th must be accompanied by the \$15 per-person surcharge or they will not be accepted. NO SIGN-UPS ACCEPTED AFTER January 23rd.

If my child cannot attend the trip for *any reason*, I promise that my son will call both his Patrol Leader and Mr. Bennett (267 615 4236) no later than 2 hours before the scheduled departure time. “No shows” will be charged the greater of: (a) fees for participation and (b) \$75, notwithstanding the reason. If I am signing for a Scout, I authorize such funds to be deducted from my son’s Troop account and I promise to pay any unpaid portion of such fee ASAP, with the understanding that my son may be precluded from attending other Troop trips unless such amount is paid in full.
