The Ohio Revised Code and Village's personnel manual do not specify that the holder of public records must allow the requester to "duplicate" or "reproduce" copies of the record themselves. The Village is required to duplicate/reproduce the copies of its public records. It clearly requires only the public officials/persons responsible for public records to perform the duplication/reproduction, or to refer it to a third party for reproduction under some circumstances.
