It's time for our annual subscription drive! Your continued support helps Delaware Township Volunteer Ambulance Corps (DTVAC) provide life-saving emergency services to our community. For nearly 50 years, we have proudly served the Delaware Township - Dingmans Ferry and the surrounding areas with exemplary emergency medical services. Your contribution helps sustain our essential service and ensures we are ready when you or your loved ones need us most.

DTVAC is a nonprofit organization established in 1975. We rely on voluntary contributions, grants, donations, municipal funding, and service billing to maintain our operations. We are a combination service, employing career staff and volunteer personnel committed to delivering high-quality emergency medical care. By participating in this year's subscription drive, you directly help offset the rising costs of operating our organization, from maintaining ambulances and medical equipment to providing ongoing education and training for our personnel.

Each year, DTVAC responds to hundreds of emergency calls in Delaware Township alone. Our team provides emergency care and safe transport to hospitals across Pennsylvania, New York, and New Jersey. Over the past few years, we've significantly reduced response times to 911 calls and expanded our capacity to meet the growing needs of our community. As call volumes continue to rise year after year, your support becomes even more critical to maintaining the level of care you deserve.

Our commitment to excellence is evident in the high standards we maintain in serving our community. DTVAC is licensed by the Pennsylvania Department of Health's Bureau of Emergency Medical Services to provide basic, intermediate, and advanced life support—the highest level of prehospital care available in the state. We are also proud to have earned Master-Level recognition from the Pennsylvania EMS for Children Program, underscoring our dedication to delivering outstanding pediatric emergency care.

Operating a modern ambulance service comes with significant costs. Ambulances, medical supplies, vehicle repairs, medications, and personnel expenses add up quickly. Ambulance transports can cost more than \$2,500 per trip, and many insurance providers, including Medicare, do not cover the entire bill. To ensure our community has access to the care it needs, we must both bill for services and solicit donations to close the gap.

Your participation in our subscription drive benefits both you and our organization. Subscribers are protected from out-of-pocket costs for insurance-covered ambulance services, including copays and deductibles, as allowed by law. Additionally, subscribers receive a 50% discount on services not covered by insurance, such as non-emergency transports or patient assessments when no transport is needed. By subscribing, you safeguard yourself and your family from unexpected medical expenses while directly supporting the emergency care your community relies on.

Joining our subscription program is easy. Simply complete the form below and return it with payment in the enclosed envelope. Every contribution helps us purchase life-saving equipment, medical supplies, and medications. Your support ensures that DTVAC remains ready to respond 24 hours a day, 365 days a year.

## About the Subscription

As a subscription member, you will not be billed for balances owed on services that are partly covered by your insurance carrier, including insurance copays and deductibles, except for deductibles as mandated by Federal Law. On services not covered by your insurance, such as non-emergency transports and patient assessments (patient is not transported), you will receive a 50% discounted rate. If you do not have insurance, you will receive 50% off all bills from DTVAC. Because a large percentage of our emergency dispatches are in other municipalities, we allow anyone to become a DTVAC subscription member. Subscription plans are valid from December 24, 2025, through December 31, 2026. There is no "proration" for those who wait to subscribe, so the sooner you sign up, the greater the benefit!

## The fine print . . .

### Subscription Terms

Medical insurance typically pays for ambulance transportation according to the terms of your policy. However, there are instances where subscribers may be financially responsible for services not covered by their insurance. This may include situations where the transport is deemed not medically necessary, is not provided, or when another form of transportation is used instead. Additionally, uninsured subscribers will be responsible for 50% of the standard charges imposed by Delaware Township Volunteer Ambulance Corps (DTVAC). Subscribers may not be notified of non-coverage at the time of service. This subscription does not cover services provided by other emergency medical service providers.

DTVAC will generally bill your insurance company directly through a third-party billing service. By paying the subscription fee, you agree to assign all ambulance benefits you or any covered family member may receive from insurance or other third-party payers to DTVAC for services provided under this program, now or in the future. Failure to comply with this agreement constitutes fraud and will void your subscription benefits. It is important to note that this subscription program is not an insurance product and is not an offer to purchase or sell insurance. Medicaid beneficiaries are not eligible to participate in DTVAC's subscription program.

DTVAC routinely provides mutual aid to many neighboring municipalities. For this reason, there is no residency requirement for subscription membership. The subscription program is not a contract guaranteeing the provision of ambulance services. If DTVAC is unavailable, mutual aid ambulance services may respond. Additionally, the terms and conditions of this subscription program are subject to change without prior notice. Medicare beneficiaries remain responsible for copayments and deductibles as required by law. Acceptance into the subscription program is at DTVAC's sole discretion, and subscriptions may be canceled or revoked by DTVAC. By participating in this program, subscribers acknowledge that DTVAC will bill available third-party insurance for services rendered and agree to forward any insurance payments received directly to DTVAC.

### Annual Non-Discrimination Statement

Delaware Township Volunteer Ambulance Corps is committed to providing an inclusive and equitable environment in all its activities and operations. DTVAC does not discriminate against individuals based on race, color, religion, sex (including gender identity and expression), sexual orientation, age, national origin, disability, marital status, military or veteran status, political affiliation, or any other characteristic protected by applicable federal, state, or local laws.

### 911 Sign Reminder

When the ambulance service, fire department, or police are dispatched, they are given the "911" address by the Communications Center. Unless this address is posted at the front of the residence or building, it is very difficult to locate the emergency in a timely manner. We urge all residents and business owners of Pike County to have their "911" number posted near the street in front of their home or business to ensure a timely response in the event of an emergency. The Pike County Emergency Management assigns street addresses. If you do not know your 911 address, call the Emergency Management office during weekdays at (570) 296-1911. Supplies for these signs are available at many hardware stores. In addition, as a community service, Delaware Township Volunteer Ambulance Corps sells address signs at a minimal cost. ### Help Wanted:

We are a combined service that uses both career and volunteer staff. We utilize volunteers in our organization's vital activities, including responding to 911 calls, fundraising, administrative functions, and serving on our Board of Directors. Volunteers participate in our incentive program, which offers free uniforms, training, college tuition assistance, gym equipment access, and more. ### Car Seat Checks

We now offer free child seat safety inspections by qualified Child Passenger Safety Technicians at our ambulance station. Inspections help ensure car seats are appropriate for the child's age and size and installed correctly. These checks take approximately twenty minutes and are by appointment only. Call us to schedule!
