1. Proof of insurance is required with registration form. Vendor must furnish a certificate of liability naming North Iowa Fair Association (NIFA) as additionally insured during Fair. Certificate must be provided by July 10, 2019 and held on-site during Fair.
2. A Temporary Food Establishment License must be posted for each food vendor. Applications are available online at www.cghealth.com or by calling the Cerro Gordo County Department of Public Health at 641.421.9335.
3. The NIFA, its agents, employees and affiliates assume no risk and shall not be responsible for any damage, injury, loss, legal action or expenses that may arise or come to the exhibitor or his employee, or his goods or property, or to the public from any cause whatsoever.
4. The NIFA/coordinator reserves the right to cancel any or all future reservations made by any vendor acting in any manner deemed to be inappropriate.
5. Vendors must be present and set up during all hours open to the public. No early tear downs. No duplications of following Chamberlain Midway food items: corndogs, cotton candy, lemonade, haystack onions, funnel cakes. Please eliminate these items from your menu.
6. Spaces may not be sub-leased.
7. No additional liquor license is allowed on the NIFA property.
8. Teardown begins at 5:30 p.m. Sunday.
