## SPANISH VALLEY WATER SEWER IMPROVEMENT DISTRICT

Regular Meeting -----July 10, 1985

The meeting was called to order by the Chairman, W. ATTENDANCE Darwin Gilger at 7:00 P.M. Other Board members present were Dan Holyoak, Neal Dalton, George White and Linda McKinney.

Others present were Robert Christie, Robert Lammert, Mr. & Mrs. Ben Smith, Nikki Bower, Dale Pierson, Barbra J. Ossola and Roberta R. Highland.

Roberta Highland read the minutes of the meeting of MINUTES June 12, 1985. Linda McKinney moved the minutes be approved as read. Dan Holyoak seconded. MOTION CARRIED.

Mr. Robert Christie stated he had paid the connec- ROBERT tion fee in 1983, and had a series of bad luck. He asked CHRISTIE that since he had a good septic system, to be allowed to go ahead and pay the monthly assessment until he has enough money to connect to the sewer. Dan Holyoak moved his request be granted. Neal Dalton seconded. MOTION CARRIED.

Mr. Lammert asked what the Board intended to do ROBERT about the manhole on his property. Dale stated that LAMMERT what apparently happened, the contractor got off the easement when the sewer was put in. He stated the sewer and the man hole was off the easement. Mr. Lammert was asked what he really wanted. Mr. Lammert stated that if he received a free connection, he would give an easement for where the man hole is situated. Dan moved a free connection be given. Neal seconded. Mr. Lammert asked about maintenance on the line, and was told the easement would allow for line maintenance. Mr. Lammert stated he would think about it and come to the next meeting with a decision.

Mrs. Ben Smith stated she had no letter of notifi- BEN SMITH cation and did not want to pay the fee until she was hooked on to the sewer. After a discussion of the water situation, Mrs. Smith stated she did not want to pay for the sewer. Darwin stated that until the law was changed, he did not think there was anything the Board could do. Harry agreed. After a discussion of the legalities of charging a sewer fee, Dan moved the Smiths be given another letter, and waive this current month's fees. George White seconded. Linda objected on the ground this was a bad precedent. Vote was called, and the vote was Dan Holyoak, George White and Neal Dalton Yes, Linda MckInney Nay. MOTION CARRIED.

Mrs. Nicki Bowers stated she had voted against the NICKI BOWERS sewer and would not hook on to the sewer nor pay any fee.

Harry Snow stated that there is a method of CHARGING UNcharging the fees to the taxes, by certifying to the PAID CHARGES Treasurer or Assessor. He suggested this go through the TO TAXES

County Commissioners.

Dan Holyoak stated that Ron and Glen Holyoak had RCN AND GLEN contacted him and they do not have a right of way from Ray HOLYOAK Holyoak to connect to the sewer. Dale stated he had talked to Jim Adamson and if a property owner will sign a statement that he will not give a right of way, that will constitute a just cause for not connecting to the sewer. Dan stated that he would take that word back to them.

Dan stated he had had some complaints about Teri's TERI TIBBETTS attire. Dale stated he had also had some complaints and intended to talk with her.

Dale reported the moving days were tentatively set MOVING DAY for July 18th and 19th. It will be advertised that the office will be closed those two days for moving purposes.

Dale reported that the City planned putting in a 6 SEWER LINE TO inch sewer line to Old City Park, and that he had talked with OLD CITY PARK Dan about should the District should pay the difference and put in an 8 inch line so that the line can in the future be extended as a main. Dale gave the board a diagram of the original plans, and that he had proposed the City put in an 8 inch main so that it could later be extended to other potential customers. He stated the additional cost would be \$1.04 per foot for 960 ft. Dan stated this would open up a Canyonlands Circle and parts of Juniper Lane. Dale stated he had reached a verbal agreement with the Mayor. Dan moved the District cooperate with the City and pay the extra cost to put in the 8 inch main. Linda McKinney seconded. MOTION CARRIED.

Harry Snow stated he had answered the complaint of ELDON RAY Eldon Ray and gotten an extension of time.

Dale stated that Art Althoff had come in and would ART ALTHOFF come to the next Board meeting because the commercial zoning allowed for residences, and that he had also invited Jr. Nordfelt to that meeting. Dan suggested Mr. Altoff might be charged a business and residence connection fee, and pay the commercial fee monthly charge. The contract will be as a business and the monthly charge will be computed as a business.

Dan reported that with regard to Milo Randall'sMILO RANDALL connection, he felt they should not be forced to connect until the line is put to their property, or they make an agreement for an access easement to the existing sewer.

With regard to the Holloday case, the Federal Case HOLLODAY vs. has been stayed until the condemnation suit is settled. SVW & SID
