AMMENDMENT to HEADURITES RANCH

AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR HEADWATERS RANCH

This Amendment to the Declaration of Covenants, Conditions, and Restrictions ("Declaration") for Headwaters Ranch is made this 9th day of May, 2025, by the undersigned authorized representatives of the Headwaters Ranch Property Owners Association ("Association").

RECITALS

A. The Declaration was recorded on 10/4/2019 in the official records of Yavapai County, Arizona, as Document No. 2019-0052972.

B. Article 6, Section T, of the Declaration requires that all electric power lines within Headwaters Ranch be installed underground.

C. Pursuant to Article 8, Section C of the Conditions, Covenants and Restrictions of the Association, an amendment may be made upon the affirmative vote of at least 67% of the eligible membership in good standing.

D. A duly noticed meeting of the members was held on May 7, 2025, at which a quorum was present, and 67% of the membership ballots were in favor of the amendment set forth herein.

AMENDMENT

NOW, THEREFORE, the following amendment is hereby made to the Declaration:

- 1. Article 6, Section T, requiring all electric power lines to be buried underground, is hereby deleted in its entirety and shall be of no further force or effect.
- 2. All other terms and provisions of the Declaration not modified by this Amendment shall remain in full force and effect.
