XC: Grasshopper- 7 Fences, Intro- 8 Fences, Starter – 9 Fences, BN- 12 Fences, Novice- 15 Fences No telephone entries accepted. All entries must be completed in their entirety. Checks payable to CCEC. One entry per Horse/Rider combination. Payment is due with entry – not considered complete without it. No Entry money returned for rider cancelation of entry, after the closing date. Show Management reserves the right to change ride times when deemed necessary to facilitate the timely completion of the show.
