We are thrilled to announce that the Craig Tribal Association has been awarded the **Tribal Broadband Affordability Program Grant**, a \$2.4 million grant that will cover household and business broadband services for the next **five years**.

This funding ensures that our citizens and businesses will have access to affordable, reliable internet, fostering better connectivity, education, business opportunities, and overall quality of life.

The following are the requirements set forth in order to qualify for funding:

- [] Only **one application** can be submitted *per* Tribal Member's Household, for those living in the **Craig neighborhood** and who are 18 years or older.
- [] Cannot be dually enrolled. Being dually enrolled will **DISQUALIFY** members of all distributions.
- [] The application must be filled out completely with a required signature, certifications, and a copy of an internet bill.
- [] Applications will be reviewed and processed in the order that they are received.
