- 6. Does the Facility currently allow inmates to transfer money from their commissary account to their phone account? If not, is this something that interests the Facility?
- 7. Does the current commissary provider distribute commissary to the inmates? If so, how many people does the current commissary provider supply for this, how many hours does it typically take, and what is the pay rate for the Distributor?
- 8. What is SRJA's current commission rate?
- 9. What are the contents of the indigent kits currently used by the SRJA?
- 10. The Specifications mention a booking kiosk. Is the Facility also interested in a lobby kiosk for the public to add funds via cash or credit card to inmate's accounts?
- 11. In addition to inmates ordering via the telephone, is the Facility interested in the ability to put a commissary link on current inmate phone provider tablets/kiosks to allow for additional ordering options?
- 12. Will RFP responses be opened publicly?
- 13. Specifications state that "The attached anti-collusion/nondiscrimination form incorporated herein must be executed and returned with Request for Proposal documents to receive consideration.
