Last year's Gundog stakes were all "Majors" with the open gundog being a 5 point major. All adult stakes will be retrieving done on a call back basis. We expect this year to be the same. Seemed like just about all the pointing breeds were represented last February. We had GSPs, Weims, Vislas, Brittanies, Pointers, Spononies, Red Setters, English Setters, Irish Setters to name a few.

The grounds are great for a walking field trial with the fields being flat and strips mowed. Throw in a some nice tree lines and few far out objectives and the perfect grounds are at hand. The club house overlooks the fields that from inside, you can watch 95% of the brace with your binoculars. Heated and warm with just the right atmosphere makes these grounds a field trialers dream. The Bird hunters club will be providing breakfast, lunch and dinner for a very reasonable price. Last years meals could not have been any better, unless my mama had done the cookin herself. The club member enjoyed having us and they showed it in the way they treated everyone. I don't think any of us were strangers to them. They took the word "hospitality" to a whole new level. There are several restaurants and hotels within a 20 minute drive of the grounds. There are a limited amount of electrical hooks ups on a first come first serve basis. There is also a large Amish Community offering home cooked meals and several shops in the area.

For those of you that think your dog just might have the "right stuff" and would like to try trialing, this is the game to play. This is the **ONLY** AKC field trial to be held in the state of Indiana this year.

If you are not familiar with field trials, a walking trial means that all handling will be done on foot. Similar to hunt tests but instead of your dog either passing or failing, a field trial dog has to meet all the standards of the stake but the additional role of competition. Placements are awarded by how well your dog did against the rest of the dogs entered.

### SCRATCH POLICY

Full refund will be made prior to the drawings, after the drawings are held, only bitches in season, injury, illness, or death with a veterinarian's statement (Chapter 1, Sec 5), shall receive a full refund. The Hunt Test Secretary must receive the veterinarian's statement within 10 working days after the event in order to receive a full refund.

### COURSES, GROUNDS, ATTIRE AND BIRDS

All levels will run on a single course. All tests will be walked – horses will be used by officials only. In accordance with AKC rules, Chap. 1 Sec. 16, all dogs must be on leash at ALL times except when actually being tested. Bitches in season shall not be eligible for entry and shall not be allowed on the grounds. All handlers, judges, workers and gallery members must be attired in an article of Blaze orange while on the Club's grounds. **Quail** and/or Chukars and/or Pheasant and/or Pigeons, to be released for all test levels.

### PRIZES

Standard AKC Orange Rosettes will be awarded to all dogs that receive a qualifying score.
