ORDINANCE NO. 2018-11

AN ORDINANCE AMENDING ORDINANCE NO. 2015-5

WHEREAS, on May 13, 2015, the corporate authorities of the Village of Chapin, Illinois, passed and approved Ordinance No. 2015-5 entitled *An Ordinance Repealing Ordinance No. 2007-9 and Establishing Revised Procedures for Collecting Delinquent Sewer and Water Accounts and Disconnecting Service Thereof.*

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois, as follows:

SECTION 1. Ordinance 2015-5 is amended by deleting the current language in Section K of Section 2 and replacing it with the following new language:

Section K. Returned Checks. There shall be assessed a charge of \$55.00 on all checks returned to the Village due to insufficient funds and on all returned, rejected or denied payments through an Automated Clearing House (ACH) Network or similar type of electronic payment system.

SECTION 2. All ordinances, resolutions or parts thereof in conflict with the provisions of this ordinance are, to the extent of such conflict, hereby amended to conform to the terms of this ordinance.

SECTION 3. This ordinance shall be in full force and effect ten (10) days after passage, approval and publication in pamphlet form as required by law.
