FARMERS MARKET ON GRAND PARKWAY PARTICIPATION AGREEMENT

The vendor understands that there is a \$15 non-refundable application fee that must be included with the application in order for it to be reviewed. The vendor understands that if accepted, their \$45 annual fee must be paid before they can start at the market. The vendor understands that their annual fee will be due on the anniversary of their start date. In addition, each vendor pays a day fee per stall for each market attended. Each week the vendor is at the market, there is a fee of \$25 for a 10x10 space. Vendors acknowledge that these fees may change per the Board of Director's request. Vendor has read and understands the Market Rules for the Farmers Market on Grand Parkway and is bound by the terms and conditions outlined there. Vendors may sell only what is listed on this application, and any additional items that a vendor would like to sell must be reviewed by the board of directors. Vendors are responsible for the quality and safety of what they sell. We, the undersigned, agree to comply and abide by the rules and regulations of the Farmers Market on Grand Parkway. This agreement admits the producer under the same terms and conditions as other participating producers and does not constitute permission to participate if the market's rules and conditions are violated.

FARMERS MARKET ON GRAND PARKWAY INDEMNITY AGREEMENT

Minimum Coverage: You must provide proof of general liability insurance with a minimum limit of **\$1,000,000 per occurrence and \$2,000,000 aggregate.**

Certificate of Insurance (COI): A copy of your COI, also known as an ACORD form, **is required for all vendors** to be eligible for participation. The COI must list **Farmers Market on Grand Parkway and Church of the Holy Apostles - COTHA** as an **Additional Insured.**

Submitting Proof of Insurance: A copy of the COI can be uploaded with this application or submitted after acceptance by email. A printed copy must be submitted directly to the market manager before market participation.

Failure to provide and maintain the required insurance coverage may result in the forfeiture of the market space, and refunds will not be issued.
