I, the undersigned parent/legal guardian of _____, hereby agree to abide by the following policies and procedures of Illinois Dance Conservatory.

PAYMENT POLICY

I understand that payment is due at the time of registration unless financial agreement is in place (see terms below). Preferred payment method will be checks and cash. All credit card transactions will incur a 3% fee per transaction fee. A \$39.00 insufficient funds fee, plus any additional bank fees incurred, will be charged to customer as a result of a returned check. Declined credit card payments will result in a \$25.00 fee.

FINANCING PLAN POLICY

- Financial plans/agreements are available as a courtesy to the families of IDC. Payment plans are only available with our automatic payment option. Credit card information will be kept on file and charged each month as per the IDC Financial Agreement. Financial plans can be set up for monthly repayment.
 - Payments are typically set up using a 9-month payment duration, when enrollment date allows.
 - Payments are due on either the 1st or 15th of the month.
 - The first payment and annual registration fee is due at time of registration.
 - If student account is past due for any reason, a \$15 late fee will be assessed on day 5 of delinquency and for each additional month the account remains past due! Student will be excluded from class(es) if account is more than 10 days in arrears until account is brought to a current status.

All financial agreements between student/parent must be in writing and may only be terminated by paying account in full at time of termination request. Due to the no refunds policy at IDC, if for any reason a student should decide to withdraw from classes, **the full balance on account at time of withdraw will still remain the responsibility of the parent/guardian and will be expected to be paid in full. NO EXCEPTIONS!**

RETURN, REFUND & CREDIT POLICY

No refunds or credits will be allowed after the 1st day of student's scheduled classes.

In the event of an injury resulting in the inability of the dancer to complete their dance season, credit will be considered for any UNUSED classes or privates when accompanied by an official doctor's note. Credit will be allowed only from date of receipt of written doctor's notice forward.

In the event credit is authorized due to injury, only an IDC Student Account Credit will be given, to be used for a future enrollment option with IDC. IDC will, under no circumstance, issue a refund! No Exceptions!
