I entered the NW1 trial.

We Q'd in all 4 elements...25 points each for a perfect score of 100 and a title. She did not incur any faults. Her times were beyond my expectation.

Container search 19 seconds, Vehicle search 35 seconds,
Exterior search 36 seconds Interior search 29 seconds.

The judge who did the vehicle search said he would not have done anything differently. For the interior search, I opted off leash and she did very well. I stood in the center of the room and let her work. When I was done, the judge told me that my dog knows what she is doing and when she does her NW2 trial, I should try standing at the door and give her the entire room because once should found the first hide, and I said alert started looking for another hide. The judge that did the container and exterior searches complimented me on her understanding of scent cones and how she follows them to source.

Needless to say - an extra special supper that night.

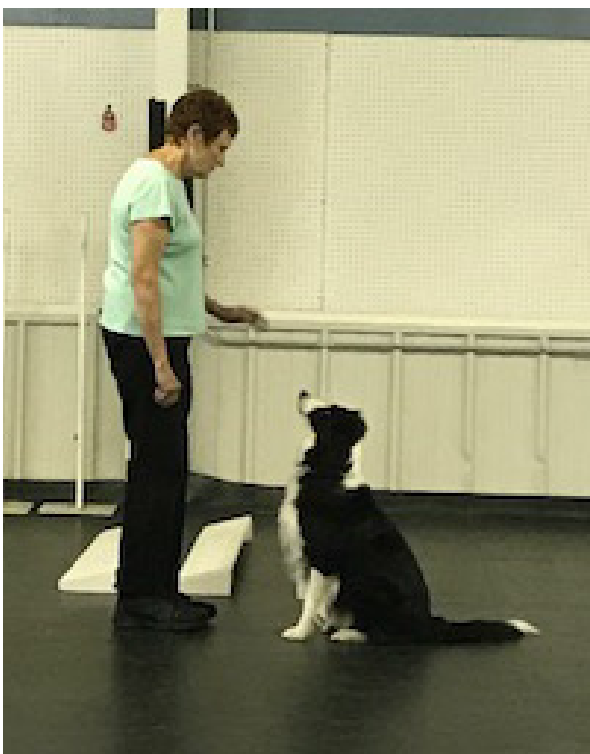

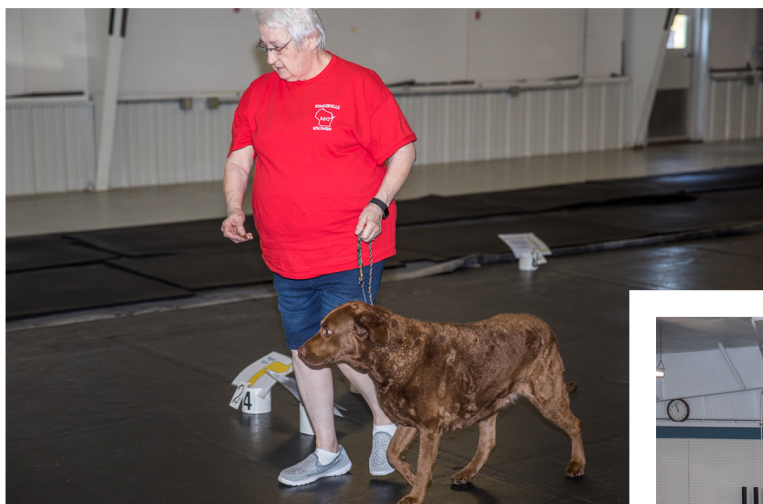
