

ORDINANCE NO 706

An ordinance levying a special tax provisionally, to pay the cost of grading, curbing, guttering and paving Oak Street from the North line of Second Avenue in said city, to the north end of Oak Street, except the intersection of Oak and First Avenue, in said city, therefore

Be it ordained by the Board of Commissioners of the City of Garnett, Kansas:

Section One. That in order to provide for the payment of the cost of grading, curbing, guttering and paving Oak Street from the North line of Second Avenue to the north end of Oak Street, in said city, except the intersection of Oak street and First Avenue, in said City, Specially assessments are hereby levied, provisionally, upon the lots, parts of lots and pieces of ground on either side of said Oak Street, liable for taxation to pay the cost of said improvement as follows:

Assessment against each piece of property to pay the cost of paving, curbing guttering Oak Street.

days after the publication of this ordinance.

Section Three This ordinance shall take effect and be in force from
and after ten days from its final passage and publication in the official
paper in said city.
