

TOWN OF MARBLE  
ORDINANCE TO ADOPT BUDGET #4

AN ORDINANCE SUMMARIZING EXPENDITURES AND REVENUES FOR EACH AND ADOPTING A BUDGET FOR THE TOWN OF MARBLE, COLORADO, FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY, 1992, AND ENDING ON THE LAST DAY OF DECEMBER, 1992.

WHEREAS, the Board of Trustees of the Town of Marble has appointed the Board to prepare and submit a proposed budget to said governing body at the proper time; and

WHEREAS, the Board of Trustees has submitted a proposed budget to this governing body on October 5, 1991, for its consideration, and;

WHEREAS, upon due and proper notice, published or posted in accordance with the law, said proposed budget was open for inspection by the public at a designated place, a public hearing was held on November 02, 1991, and interested taxpayers were given the opportunity to file or register any objections to said proposed budget, and;

WHEREAS, whatever increases may have been made in the expenditures, like increases were added to revenues so that the net remains in balance, as required by law.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MARBLE, COLORADO:

Section 1. That estimated expenditures for each fund are as follows:

Section 2. That estimated revenues for each fund are as follows:
