- Officers continue to conduct Directed Patrol in the area of 38 Ave N and 49 and in the area of Disston plaza especially in the rear.
- Several Notice to Appear have

been issued to subjects Panhandling in the area of 38 Ave N and 49 St N. One Notice to Appear for Open Container has been issued at the bus stop located on the southeast corner of 38 Ave N and 49 St N. Four Trespass warnings have been issued at the plaza and two Trespass Warnings have been issued at the Shell gas station.

- Contacted Logan at PSTA requesting No Trespass Signs be posted at the Bus Stops (Shelters). I was informed the Shelter at 38 Avenue N and 49 Street N on the southeast corner by the Shell gas station will be replaced with a newer Shelter. As far as the benches located behind the bus stops, PSTA will not be removing them.

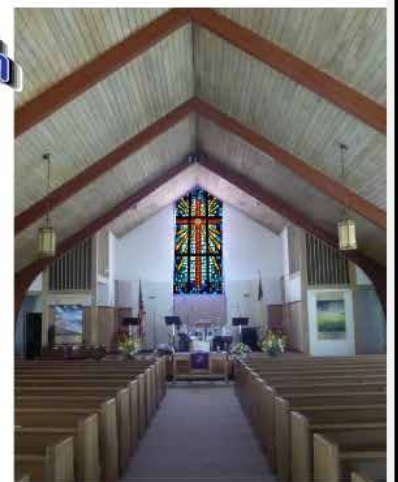



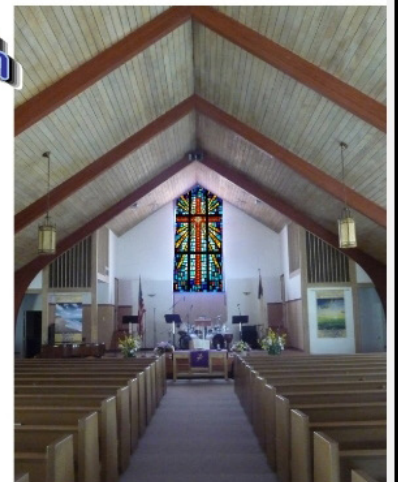

• **FINANCIAL HELP** is available for St. Pete residents who are falling behind on rent due to the pandemic. The city is participating in the Pinellas County Emergency Rental Assistance Program, which provides financial assistance for individuals and families who have lost their jobs or have had a significant reduction in income due to the pandemic.

Eligible applicants may receive funds to cover missed rent payments and future rent payments, up to 12 months in total. Residents can find eligibility criteria and apply on the county’s Covid-19 website at www.bit.ly/pc-rent. Tenants who are overdue on rent should not wait for an eviction notice to seek help and may already be eligible for financial assistance based on the criteria.

Homeowners in St. Pete that have been impacted by the pandemic may be eligible for financial assistance through the City of St. Petersburg’s Mortgage & Utility Payment Assistance Grant Program. More information and qualifications can be found at stpete.org/MortgageAssistance.
