This Non-Language Specific six (6) credit hour, Instructor led course\*, will outline and familiarize the Student with Professional Interpreter protocol used in conjunction with court testimony and investigations specific to **Sexual Assault** and **Domestic Violence** Investigation Units. Students will gain a broad understanding of a variety of criminal Investigations, investigation specific terminology, and the type of crimes that demand specialized Investigators and specific terminology during courtroom testimony.

This Course will be broken in to two sections with the first topic covering Sexual Assault Investigation Units. Topics will include, interpreter assisted interviews, sex related crimes, terminology, and medical examination protocol to name a few. The second portion of the class will cover domestic violence investigations which includes various “domestic” related crimes, methods of investigations, terminology, interpreter assisted interviews, social impact on victims and families and much more. **\*Course may also be presented via webinar with “live” interactive Instructor facilitated participation.**
