## 2012 Scholarship Program

Lorie Hougland, Scholarship Chairperson of the 2012 HMC Scholarship Program, reports that as of April 1, 2012 five (5) scholarship application packages have been distributed in response to requests received from sponsoring MHC members. To save postage and to allow greater flexibility for the students, this year's application was distributed electronically for the first time. To qualify to be considered for the scholarship, a completed copy of all required documentation, as specified in the scholarship application package should have been submitted by May 1, 2012.

For the 2012 academic school year, the MHC is again offering a one-time \$2,000 academic, college scholarship to an eligible graduating high school senior who is related to a sponsoring dues-paying member of the MHC. The scholarship is competitive and selection is based upon academic merit and ability that recognizes scholastic excellence. The applicant should have a SAT of 1150 or higher (Critical Reading and Mathematics sections) OR ACT of 25 or higher. The MHC Scholarship Committee has oversight responsibility and authority for all academic scholarships awarded by the Chapter. Each applicant is ranked by the following criteria:

High School Performance, Class Rank, GPA (weight 35%)  
National Tests SAT or ACT (weight 25%)  
Essay (weight 20)  
Three Confidential References rating "Qualities" (weight 20)

In a case where this scoring results in a numerical tie between two or more applicants, then the highest GPA will be the tie-breaker

In May, the Scholarship Committee will evaluate all applications that were received - COMPLETE – and the 2012 scholarship will be awarded to the most outstanding applicant at the June 12<sup>th</sup> luncheon. Invitations to attend the June luncheon will be extended to the successful applicant, his/her parents, and his/her sponsoring MHC member(s) for the presentation of the award. Be sure to attend the luncheon to wish the selected scholarship winner much success as he/she enters the next era of their advanced learning
