

IMPORTANT ORDINANCE INFORMATION

Here is a list of ordinances and resolutions with brief descriptions of each that are important for residents to know who live or own property inside the city limits of Westmoreland. If you are found in violation or a complaint is brought before the city of any of these ordinances/resolutions, you will receive a letter from the city attorney giving you a time frame to work with the code enforcement officer to correct the violation.
