## **Bloomfield Police Department Monthly Report for April 2017**

This is the monthly report for the Month of April 2017 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Wednesday, April 5<sup>th</sup> at approximately 3:31am officers executed a traffic stop on Hwy 12 for a speeding violation. At the conclusion of the traffic stop a 19-year-old male subject from Lake Villa, Illinois was arrested and confined in the Walworth County Jail. Charges of possession of marijuana with the intent to deliver and possession of drug paraphernalia have been forwarded to the Walworth County District Attorney's office. Additionally, the 19-year old was issued a traffic citation for the speeding violation.

On Thursday, April 13<sup>th</sup> at approximately 4:30pm officers responded to a residence on Hemlock Road for a strong arm robbery complaint. At the conclusion of the investigation charges of robbery with use of force, burglary, theft, battery, bail jumping and criminal damage to property have been forwarded to the Walworth County District Attorney's office for a 17-year-old male who fled the scene prior to officers arrival. An arrest warrant has been requested.

On Sunday, April 16th at approximately 12:55pm officers responded to a welfare check complaint on Violet Road. At the conclusion of the investigation a 49-year-old male was arrested and confined in the Walworth County Jail. Charges of bail jumping, disorderly conduct, resisting/obstructing a police officer and battery/threat to law enforcement officer have been forwarded to the Walworth County District Attorney's office.

On Sunday, April 16<sup>th</sup> at approximately 7:56pm officers responded to a domestic disturbance complaint on Mariondale Road. At the conclusion of the investigation a 21-year-old male was arrested and confined in the Walworth County Jail. Charges of disorderly conduct and bail jumping have been forwarded to the Walworth County District Attorney's office.

On Thursday, April 20th at approximately 9:53pm officers responded to a domestic disturbance complaint on Poinsettia Road. At the conclusion of the investigation charges of disorderly conduct and criminal damage to property have been forwarded to the Walworth County District Attorney's office for a 24-year-old female who was not taken into physical custody.

On Friday, April 21, 2016 at approximately 12:46pm officers responded to a domestic disturbance complaint on Hwy H. At the conclusion of the investigation a 36-year-old male was arrested and confined in the Walworth County Jail. Charges of disorderly conduct, battery, criminal damage to property and strangulation/suffocation have been forwarded to the Walworth County District Attorney's office.

On Tuesday, April 25<sup>th</sup> at approximately 7:35pm officers responded to a report of a stolen ATV which was located in a marshy area off of Violet Road and Daisy Drive. Thanks to vigilant citizens who reported the information officers were able to recover a stolen ATV and a stolen rifle which had both listed in the March 2017 police department monthly report. Both incidents remain under investigation.

On Sunday, April 30th at approximately 5:43pm officers assisted the Bloomfield-Genoa City Fire/Rescue Department with a chimney fire at a residence on Cedar Road. The fire was ultimately extinguished and the home did suffer damage as a result of the fire. There were not any injuries reported during this incident.

During the month of April 2017 the Bloomfield Police Department responded to 627 calls for service compared to 1018 calls for service during the month of April 2016. During the month of April 2017 the police department affected 95 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 86 arrests during the month of April 2016.
