General Meeting on June 17 About Teaching and Fund Raising

For the first part of our demo on June 17th, Artists Skip Wiese and Pat King will be instructing two non-artists in painting their favorite Waukegan scenes. This will be an education for our members in how experienced teachers approach the challenge of teaching non-artists. The paintings produced will be part of a larger fundraising project to benefit arts instruction in areas of need.

Ty Rohrer, Waukegan Park District's Manager of Cultural Arts, will emcee, explaining the participants' backgrounds, questioning them, and taking questions from the audience.

After the break, Pat and Skip's coaching will continue while Ty talks to the audience about how the Waukegan Park District can turn our members' coaching of prominent non-artists into an entertaining fund-raiser. Funds raised could be split between the artists and/or the League and the non-profit organizations that could benefit from arts education.

This should be a wonderful educational demonstration and discussion.


July: Member Leslie Scott, Scratch Art

Les has had a number of exhibits in the area, and decided not to have an artist reception here.

Leslie "Les" Scott grew up observing the natural world. To make a living he studied and became a graphic artist in the commercial world, but has now returned to those memories. Here he shares them using the little-known medium of Scratchboard. We certainly see Les' artistic insights, but more than that he wants us to sense the creative potential of

the medium. Scratching black ink from the surface of a white clay board may seem as simply the reverse of penning black ink on white paper, but in Les' hands that has yielded nuanced expression and opened doors for an artistic journey far beyond graphic arts

Legacy Collection News

Two years ago the art league board of directors approved Thom Kapheim's proposed Legacy Collection project. The art league will protect, preserve and exhibit significant works of art from Lake County artists for the benefit of future generations. Works will be accumulated from donations and from families or artists themselves. These artists do not need to have been affiliated with the art league.

Those donating art will be required to have it framed and ready for hanging. They must sign a release for transferring ownership to the collection unconditionally to the LCAL. Once art is catalogued as part of the LCAL Legacy Collection and any repairs made, it is anticipated that the collection will be exhibited at various venues. These venues will be asked to donate to the project to pay some of the expenses related to transporting, hanging and storing the pieces.

Legacy art repair, transportation and storage will become part of the LCAL budget. The initial agreement was that for two years the art will be stored at Thom and Carol Kapheim's leased building in Waukegan for the collection. Recently, however, they have purchased the building and art league storage can continue there at no cost to the art league.

2019 Plein Air Schedule

LCAL plein air activity is changing significantly. Winter and early spring sessions have been dropped because they require excessive set up, scheduling is now shared between Chris Tanner and Deb Edmunds, and our Facebook presence is being expanded. The goal is still the same as when this was started in 2006: have an ongoing and exciting experience that gives the art league visibility in the community and helps all artists – not just our members – experiment with spontaneous expression. As before, each session concludes with discussion of what worked and what didn't, but there is no instruction and no fee. As before, the group is open to painting, drawing and photography.

Deb will handle Facebook notifications, and Chris will handle e-mail notifications. Chris will make arrangements for about half the scheduled sessions and Deb will handle the remainder. Each of us will lead the sessions he or she has arranged. Here's our planned list of plein air sessions:

The list is necessarily preliminary, as it may be adjusted to resolve conflicts with other events or with Chris and Deb's personal schedules. Deb says "I will do a few more sessions if the weather is good and I have time. These I will do at several of the forest preserves. If I have one that I do at the last minute, I will give 3-6 days advance notice. All notices will be posted on our Facebook events page and sent to members and non-members via email."

Deb feels that Facebook is the key to building plein air discussions with Lake County artists. We will contact everyone on our 270-artist e-mail list and encourage them to join "Lake County Art League Plein Air Group" on Facebook.
