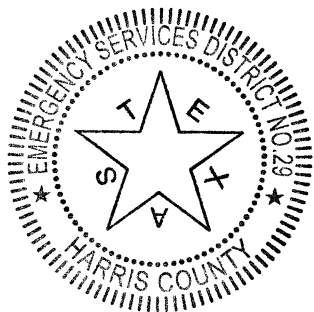

The District will consider and act upon the following matters:

1. Call meeting to order.
2. To receive public comment.
3. To receive a report from Brad Dill of BD Realty and take any action related thereto.
4. Review, discuss and take action with respect to any MMG pay applications or change orders approved by ALJ Lindsey.
5. To receive a report from Martinez Architects and take any action related thereto.
6. To receive a presentation from Dr. Ron Welch of Municipal Information Services.
7. To approve the Minutes of prior meeting(s).
8. To receive a report from the District Bookkeeper and to review and take action on the Treasurer's Report.
9. To review, discuss and take action to pay and/or ratify District bills and authorize fund transfers required for operations.
