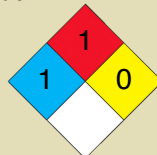

DIRECTIONS FOR USE

Insert **Super-Seaweed Pellet** into pellet applicator. Water pressure, water temperature, and other factors can affect the rate that pellets dissolve. To slow the dissolve rate, insert opened plastic container with pellet into the applicator (Note: open end away from water flow will significantly slow the dissolve rate). Treat localized dry spots on turf, sod, seedlings, nursery plants, and flower beds. Apply as needed to relieve plant stress and safely increase water infiltration into the soil. Use a test plot to establish best cultural practice. Use in conjunction with recommended applications of **SURF SIDE 37** liquid for optimal performance.
