

Town of Baldwin, Maine SELECTMEN MEETING MINUTES TUESDAY, NOVEMBER 5, 2019, 6:30 P.M.

Attendance: Selectmen: Dwight Warren, Jim Dolloff and Gerry Brown as well as members of the Public.

1. Selectmen Meeting was called to order approximately at 6:32 PM by Dwight Warren.

2. Review/ Approve meeting minutes

Jim Dolloff requested a motion to accept and approve October 22nd, 2019 meeting minutes. Gerry Brown seconded the motion; Selectmen voted 3-0 to approve meeting minutes.

3. Review/ Approve warrant

Jim Dolloff requested a motion to accept and approve November 5, 2019 warrant. Gerry Brown seconded the motion; Selectmen voted 3-0 to approve the warrant.

New Business

• <u>Saco River Corridor Commission appointments: Laurie Downey & Cheri Brunault</u> Selectmen discussed and voted to re-appoint Laurie Downey and appoint Cheri Brunault as SRCC members to represent the Town of Baldwin.

Old Business

- <u>Discuss water damage in front of building</u>: Two contractors have expressed interest in providing quotes for the repairs. Gerry took pictures of the roof and how the water is leaking down in the front. Contractor quotes should be provided by time and materials, not by the job.
- <u>Code Red discussion:</u> Reached out to Sebago regarding the use of the Code Red system. Sebago
 is not familiar with it, but reported it was part of Cumberland County dispatch. Will research Code
 Red to see if available thru Cumberland County dispatch.
- <u>Impound fee for Harvest Hills:</u> Selectmen discussed recommendations from Brandon Ruel, ACO officer. Selectmen voted 3-0 to charge \$30 for an impound fee at Harvest Hills. Currently, Baldwin is the only town that does not have a fee.
