**You agree to the following:**

1. The adoption of this companion pet brings with it a responsibility to care for and provide for this pet for the duration of his/her life as a family companion.
2. Adequate food, water, shelter, veterinary care and training will be provided throughout the pet's life. It is highly recommended (and expected) that supervised obedience training occurs in the first year that you have the dog.
3. This pet will be kept up to date on vaccinations, licensed in accordance with appropriate county requirements, and maintained in a safe and secure environment at all times. The pet will not under any conditions be allowed to roam or "run" the streets.
4. This pet will be housed with proper care and security when the adopters are away for any length of time, i.e. vacations, extensive travel, etc. when pet cannot be taken along.
5. This pet will not be chained, tied, on a runner, or contained outside for any length of time that could be considered unsupervised confinement.
6. You agree to notify Carolina ACD R&R immediately if this dog is lost or stolen. You agree to make every effort to locate the dog.
7. You agree to NEVER take this dog to an animal shelter, pound or humane society.

8. You agree to NEVER allow this dog to be used in animal research, to NEVER use the dog in dog fighting, dog baiting, or in anyway which would endanger the health or security of the dog.
9. You agree to not transport this dog in an open vehicle without a properly secured kennel or in any way to endanger the dog in transport, or to leave the dog in a closed car without ventilation, or to leave the dog in a vehicle where temperatures could reach dangerous levels.
10. The above dog will not be euthanized in a non-emergency situation without notifying Carolina ACD R&R.
11. You agree to notify Carolina ACD R&R of any change of address and/or phone number.
12. Carolina ACD R&R reserves the right to check on the condition and care of the pet during the life of the pet.
13. This contract is not deemed to be final until proof of spay/neuter is provided to Carolina ACD R&R. CACDR&R will cover the cost of the procedure up to a maximum amount of \$150. Additional costs are the responsibility of the adopter.

You accept the Dog "AS IS" and assume all risk and financial responsibilities of ownership.

You agree that, upon this adoption, Carolina ACD R&R retains no future responsibility for actions of the pet and that no assurances of future health and/or disposition are conveyed by this agreement.

**You agree that if, for any reason, you cannot continue to care for the above named pet, Carolina ACD R&R will be contacted immediately and have 30 days first right of refusal to have the dog returned. Ownership of the dog will not be transferred without the written expressed consent of Carolina ACD R&R. You agree to return this dog to Carolina ACD R&R and make no charges of any nature for licensing, care, food, or other services or items in the event that you can no longer properly care for the dog.**

You understand that any sum of money that you have given to Carolina ACD R&R has been used in caring for this pet prior to adoption or will be used for dogs in the Rescue Program and is NOT refundable. In the event that the dog is returned your adoption fee converts from a "purchase" to a charitable donation to CACDR&R.

**ENFORCEMENT OF CONTRACT:**

**Any breach of this contract in part or whole requires that you return the dog to Carolina ACD R&R or its representatives below at your expense without entitlement of any refund or damages of any kind.**

**If you fail to meet ANY of the articles listed in this contract, Carolina ACD R&R reserves the right to repossess the dog and any papers that pertain to the dog. No compensation will be due to you at the time of the repossession. Violation of ANY provisions of this contract may constitute damage to the reputation of Carolina ACD R&R, therefore you agree to relinquish ownership of the dog plus absorb the cost of any related court costs and transport.**
