

A refund will be provided if a bitch comes into season. Please inform the Trial Secretary as early as possible if your bitch has come into season and you would like a refund.

RETURNED CHECKS do not constitute a valid entry fee. The Dog Obedience Club of Las Cruces, Inc. will add a \$25.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in his or her being put on a CASH ONLY basis.

NO ENTRY FEES will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strike, or any other cause beyond the control of the Club.

A RECORDING FEE OF \$.50 will be required for each dog entered at any show held under the rules of the American Kennel Club. The AKC will also collect a \$3 Event Service Fee for the first entry of a dog and a \$3 service fee for each additional entry of the same dog in each show.

ALL ENTRIES are to be mailed with Fees to the Trial Secretary, John Dick, 304 Purple Hills Way, El Paso, TX 79912. Entries will not be accepted without fees. Acknowledgment of entries will be made as soon as practicable after the closing date. Should such acknowledgment not be received by the exhibitor within a reasonable time please contact the Trial Secretary.

DOGS MUST BE READY FOR JUDGING. The club and its committees will not be responsible for notifying exhibitors or their agents of class judging. Owners or agents alone are responsible for the presence of the dogs in the ring. Dogs need to be at the trial only at scheduled time of judging and may leave immediately thereafter unless required for further judging.

EXIBITORS ARE ADVISED TO BRING THEIR DOG'S LICENSE TAGS AND PROOF OF RABIES VACCINATION WITH THEM TO BE IN COMPLIANCE WITH EL PASO CITY ORDINANCES.

THE CLUB RESERVES the right to restrict the number of exercise pens per exhibitor and may request that crates be stacked to maximize space available for set-ups. No roping off or reserving of crating area by any method is permitted.

ALL DOGS MUST be kept on leash when not crated or in exercise pens or in the ring.

EXHIBITORS are expected to keep crating and exercising areas clean.

ANY AND ALL DAMAGE caused by the exhibitor will be the sole responsibility of the exhibitor. Parents or guardians will be totally responsible for the actions and safety of their children.

SHOW SITE

This year's trials will be held in the El Paso County Coliseum's Judging Arena, 4100 East Paisano, El Paso, TX 79905. Detailed directions to the show site will be provided in the Judging Program. SURFACE AND RALLY RING SIZE

Both rings are fully matted. The Rally Ring will be 40" x 50" in size.

Entries in Obedience will be arranged according to jump height order, beginning at 4" in ascending order on Friday, January 18, and descending order on Saturday, January 19. Handlers with multiple entries in the same class will be accommodated to the extent possible.

RING PRACTICE

Ring Practice will be held on Thursday between 4:00 and 8:00 PM and on Friday, Saturday, and Sunday beginning thirty minutes after judging has concluded. There will be a charge of \$ 5.00 for a five minute practice.
