Release of Liability

This RELEASE of LIABILITY is made and entered into this _____ day of _____, 20 ____, by and between GCEC and _____, (hereinafter designated as RIDER) and if Rider is a minor, Rider's parent or guardian as listed on the contact information.

In return for the use, today and on all future dates on the property, facilities and services of GCEC, the Rider, his heirs, assigns, and legal representatives, hereby expressly agree to the following:

1. It is the responsibility of the Rider to carry full and complete insurance coverage on his horse, personal property or himself.

2. Rider agrees to assume ANY AND ALL RISKS INVOLVED IN OR ARISING FROM THE RIDER'S USE OF OR PRESENCE UPON GCEC PROPERTY AND FACILITIES including, without limitation but not limited to, the risks of death, bodily injury, property damage, falls, kicks, bites, collisions with vehicles, horses or stationary objects, fire or explosion, the unavailability of emergency medical care, or the negligence or deliberate act of another person.
3. Rider agrees to hold GCEC and all of its successors, assigns, subsidiaries, affiliates, officers, directors, employees and agents completely harmless and not liable and release them from all liability whatsoever and AGREES NOT TO SUE them on account of or in connection with any claims, causes of action, injuries, damages, cost or expenses arising out of Rider's use of or presence upon GCEC property and facilities, including without limitation, those based on death, bodily injury, property damage, including consequential damages, except if the damages are caused by the direct, willful and wanton negligence of GCEC.
4. Rider agrees to indemnify and defend GCEC against, and holds it harmless from, any and all claims, causes of action, damages, judgments, costs or expenses, including attorney's fees, which in any way arise from the Rider's use of or presence upon GCEC property and facilities.
5. Rider agrees to abide by all of GCEC rules and regulations, including but not limited to:
 - Facility is closed on Monday (except when a holiday falls on a Monday)
 - Approved helmets are to be worn at all times while riding
 - No jumping without the trainer(s) present
 - No bare feet while on or around the horses
 - Dogs must be kept on leashes or left in the car
6. If Rider is using his horse, the horse shall be free from infection, contagious or transmissible disease. GCEC reserves the right to refuse horse if not in proper health or is deemed dangerous or undesirable.
7. This contract is non-assignable and non-transferable and is made and entered into the State of California, and shall be enforced and interpreted under the laws of this state. Should any clause be in conflict with State Law, then that clause is null and void.

By signing, GCEC and Rider and Rider's parent or guardian (if Rider is a minor) agrees to this contract and it will then be binding on both parties, subject to the above terms and conditions.
