2022 Holiday Event a Tremendous Success!

The MHC held our 2022 Holiday Event at the Cadillac Bar near downtown Houston on December 13. With over 200 registered attendees, this was our largest event of this type in our chapter's history! Thanks to all of you who attended, including our special guests from Chevron (Manish Misra, Stacy Walker, Chanel Jolly and Priscilla Brostrom) and the Houston Food Bank (Sean Crowl)!

The event was kicked off by Glenn Ewan, who led the business of electing our 2023 Board of Directors. Brian Batiste, our new President, then led the rest of the event which featured our Guest Speaker, Mr. Manish Misra, Vice President of Strategy for Chevron New Energies, shown at right. Manish explained Chevron's strategies to lower the carbon intensity of their operations while also growing lower carbon businesses. This was a very timely topic and his presentation generated lots of Q&A.



Following Manish's presentation, we recognized several long-serving members of the Board of Directors who have elected to retire from service: Maya Pendleton (2 years as Scholarship Chair); Evelyn Kasey (5 years as Event Social Chair); Judy Spencer (7 years as Secretary); George Treibel (12 years on BOD, 7 as VP) and Glenn Ewan (17 years on BOD, 7 as President). Each was presented a unique gift – a wooden scroll saw portrait handcrafted by our own George Treibel. Charlie Hancock – Membership Data Coordinator: Charlie is responsible for updating the membership master spreadsheet with such details as member information, dues status and adding new members. How did he do that?

Attendees at our 2022 Holiday Event were treated to several unique presentations courtesy of our retiring Vice President, George Treibel, shown at right. George created wooden scroll saw portraits for all of our retiring Board of Directors members and our Guest Speaker, Mr. Manish Misra, VP-Strategy for Chevron New Energies. The reaction of the recipients and audience members was fantastic. Manish even joked that his wooden portrait " ... looks better than me!"



We thought that our members might be a little curious as to how George created these wonderful mementos, so this article will provide some background. George earned a BS in Commercial Art at Lamar State College of Technology (now Lamar University) in Beaumont, Texas, in 1966. After graduating from Lamar, George served in the US Navy and in Vietnam. During his career with Gulf Oil and Chevron, he coordinated the paint, decal, sign and spanner work to support the transition from Gulf to Chevron service stations in three states.

Over the years, George has merged his talents in art and woodworking. To create these unique portraits, George imports a photo of the subject, converts it to a black and white image and re-sizes it to fit on an 8 x 10 board. He then prints the image and attaches it to a quarter-inch thick board of Baltic Birch plywood using double-sided tape. George drills a hole in a black section of the image, then inserts a scroll saw blade into the hole and uses a scroll saw to remove the black section. This process is repeated until all the black areas are cut out.

People who wear glasses present a challenge, since the wood all needs to be connected. Otherwise, the portrait can simply fall apart. If that happens, or a mistake is made during sawing, the entire process (which typically takes a day-and-a-half) needs to be restarted from scratch.

Once the scroll saw work is complete, the wooden portrait is glued to a sheet of black construction paper to provide contrast to the lighter birch. The portrait is then mounted in an antique wooden frame. The result provides a 3-D effect that is stunning. George is an active volunteer for many organizations, including the American Legion, Houston Livestock Show & Rodeo and the National Association of Destroyer Veterans. George has also faithfully served on the MHC Board of Directors for 12 years, with seven of those as Vice President. To recognize his service to our Chapter and thank him for creating these wonderful works of art, George was presented with one of the inaugural MHC President's Awards at the 2022 MHC Holiday Event.

Treasurer's Report – 12/31/22

We are starting the year with a healthy balance sheet to sustain our total expense budget of about \$11K for 2023. Based on our roster of members at the end of last year, our revenue estimate for 2023 is about \$8K. As new members who are in our "First Year Free" program renew their membership, our revenue estimate will improve accordingly. Please see the dues renewal instructions included with this newsletter.

While our 2023 Budget projects a deficit, this was anticipated and is due to software renewal expenses that occur irregularly.

Our Scholarship Fund is on track to support awarding a \$2,000 award later this year while also pre-funding our 2024 scholarship award. Thanks to all members who have donated for your generosity!

Due Dues!

It is that time of year when we ask our members to check your dues status and catch up if you are Due or Past-Due. As a reminder, our dues are only \$10/year. Your dues status is shown on the email note which accompanied this newsletter or, if you received your newsletter by postal mail, it is shown on the last page. Current members with an e-mail address on file can check their dues status by going to the **Membership** Tab on the Home Page and clicking on **Dues Status** in the drop-down menu. Those who are in the **Past-Due** category have last paid dues for the 2021 year. Those members still in this category on April 1 will be dropped from our membership and not listed in the new directory. **To avoid the last-minute rush to our UPS mailbox, we ask that if you pay dues by check, please mail them early so that we receive them no later than March 15.**

Those who are in the **Due** category have last paid dues for the 2022 year. Members still in this category on April 1 will enter a final grace year. You will not be dropped from our membership until April 1, 2024, but your dues are critical to the successful function of your Chapter. Please do catch up.

An enhancement to our website payment screen should help our members: When you elect to pay dues via Credit Card or PayPal, you will be prompted to select the dues amount in increments of \$10. The previous method asked users to select the number of years, which occasionally resulted in higher than expected amounts being charged.

2023 Scholarship Nominations Open!

It's Scholarship time for a 2023 recipient award of \$2000. Nominations are open and available to natural born, adopted or step children, grandchildren or great grandchildren of our members-in-good-standing. Go to our MHC webpage, click on the Scholarship tab across the top of the page and open the dropdown link to [NOMINATION FORM](#). Members should complete that form and return it to Keith Hall electronically (e-mail address below) or via postal mail. That initiates the process. Once screened, Keith will send documents to the screened applicant to complete with a No-Later-Than due date of May 1, 2023.

The Scholarship Committee members will individually evaluate the applicants' documents, and all will be rolled up to a final selection in June for an award presentation at one of the Q3 Neighborhood Luncheons.

Qualifications are based on four selection criteria:

- a) SAT of 1150 or higher or ACT of 25 or higher. If neither were taken, a PSAT score of 1150 or more. Please provide document from the College Board.
- b) Three completed confidential references (forms will be in the application packet)
- c) Essay up to 500 words about themselves and their career goals
- d) Official High School transcript

We will need a letter of acceptance from the college/university that the applicant plans on attending as the scholarship will be paid directly to the selected institution in the student's name.

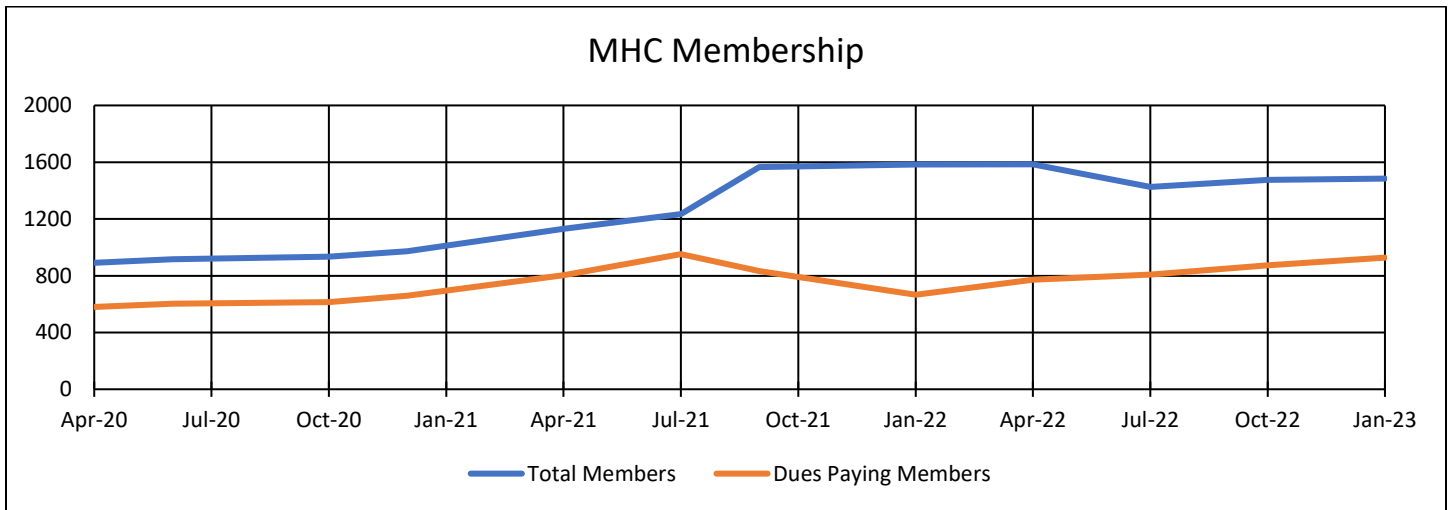

Membership

The revised MHC Membership chart, shown below, reflects the addition of membership information as of Dec. 31, 2022 and shows a 6% increase in the number of Dues Paying Members (from 874 to 928) from the 3rd quarter of 2022. After the annual removal of non-renewing members last April, our membership has grown steadily this past year. Thanks to all of you who have renewed your dues paying status! Your participation helps us keep our chapter programs going!

At this time, 453 members are enrolled in our First-Year Free program. We hope that those of you in this program have had the opportunity to participate in our Neighborhood Luncheons and found value in the friendships you have renewed and the information that was shared.

The number of Dues Paying Members continues to increase since we restarted our Neighborhood Luncheon programs in 2022, following the pandemic. Help Wanted!

Our current Membership Data Coordinator (Charlie Hancock), Communications Chair/Assistant Treasurer (Frank Coe) and Newsletter Editor (Jean Silarski) have all expressed their intentions to retire by the end of 2023. Your Chapter needs your help to fill these critical positions! Brief job descriptions for these and other available positions are shown below:

Membership Data Coordinator – The Membership Data Coordinator is responsible for updating the membership master spreadsheet and uploading data to two tables in MySQL that are used to support our web site. Updates come in three main categories: member information, dues status and adding new members. The information used for these processes arrives via email and USPS to our mailbox. This role also involves periodically picking up checks that arrive at our physical mailbox, processing payments, making deposits of any funds received to our bank account, and reporting these transactions to other BOD members. Communications Committee Chair - The Communications Chair maintains relationships with all other members of the MHC Board to facilitate communications between the various committees of the board and the members of the MHC. This position manages the processes of publishing the quarterly newsletter, publishing the annual directory, and maintaining the MHC website with current and accurate information. If you are moderately familiar with Microsoft Word and are willing to learn how to use our bulk mail techniques, we can teach you what you need to know to be successful in this role. Assistant Treasurer – The Assistant Treasurer fills in for the Treasurer when needed. The person filling this role may assist the Treasurer in the following ways: as backup contact to all financial institutions for MHC, reconciling income and expenses on a monthly basis with the MHC budget, paying annual CRA dues for all dues-paying MHC members and preparing a quarterly Treasurer’s report for the MHC quarterly board meeting. This role requires familiarity with accounting principles and knowledge of Excel. If you have questions about this role, please contact Frank Coe at fcoe@usa.net

Newsletter Editor – Creates the quarterly MHC Newsletter by collecting and assembling articles submitted by BOD members relating to their areas of responsibility along with other articles such as the Neighborhood Luncheon schedule, nominations for officers in the 4th quarter, benefit updates and other special articles. The Newsletter Editor also generates the *In Memoriam* article using Excel. Once all articles are available, they are compiled into a pleasing format and submitted to the Board for review and comments.
