**Ambulance Millage Ballot Proposal**

This proposal renews the previously approved millage of one, (1) mill for township ambulance services and will permit the township to levy up to one (1) mill for the purpose of providing funds for the township ambulance service in the years 2018-2022 inclusive.

Shall the limitation on the amount of ad valorem taxes which may be levied by the township of Loud, County of Montmorency, Michigan, against taxable property in the township be renewed by up to 1.00 dollars (\$1) per thousand dollars (\$1,000) (1) mill of the taxable value on all taxable property in the township for four (4) years, 2018-2022 inclusive, for the purpose of providing funds for township ambulance services, and shall the township of Loud be authorized to levy such millage for these purposes? If approved and levied in its entirety, it is estimated that the one (1) mill would raise an estimated \$17488.00 for the township when first levied in 2018.
