ELECTRIC

(Effective March 10, 2016)

RESIDENTIAL SERVICE

Customer Charge	\$10.00 (per month)
Energy Charge	\$0.1006 (per kWh)

Minimum Bill: The minimum monthly bill will be the customer charge.

GENERAL SERVICE

Customer Charge	Single Phase	\$12.00 (per month)
Customer Charge	Three Phase	\$28.00 (per month)
Energy Charge		\$0.0992 (per kWh)

Minimum Bill: The minimum monthly bill will be the customer charge.

SMALL POWER SERVICE (30-200 kW)

Customer Charge	\$50.00 (per month)
Demand Charge	\$6.50 (per kW)
Energy Charge	\$0.0757 (per kWh)
Distribution Demand Charge	\$1.00 (per kW)

Minimum Bill: The minimum monthly bill shall be equal to the customer charge, plus \$1.00 per kW of the highest monthly Maximum Measured Demand occurring in the current month or preceding 11-month period.

LARGE POWER SERVICE (>200 kW)

Customer Charge	\$150.00 (per month)
Demand Charge	\$7.50 (per kW)
Energy Charge	\$0.0660 (per kWh)
Distribution Demand Charge	\$2.00 (per kW)

Minimum Bill: The minimum monthly bill shall be equal to the customer charge, plus the distribution demand charge.

POWER COST ADJUSTMENT
