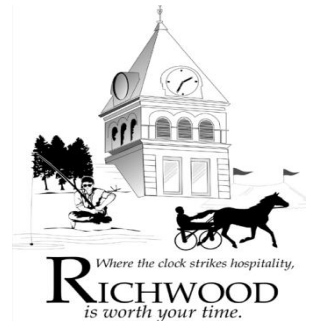

Section 1: Administrative fee schedule.

1. ADMINISTRATIVE AND STORAGE FEES FOR IMPOUNDED VEHICLES.

(a) A fee of twenty dollars (\$20.00) for administrative costs shall be charged for each vehicle impounded by the Village; and stored at the Richwood Police Impound lot. (b) The fee for the storage of vehicles will be twenty dollars (\$20.00) per each twenty- four (24) hour period, or pro rata portion thereof, with a minimum charge of twenty dollars (\$20.00).

2. Commercial and Heavy Vehicles - use of local streets; local permit and conditions.

(a). A charge of ten dollars (\$10.00), and for each hour of time or any part thereof spent by each police officer in supervising the movement of such vehicle, the applicant shall pay the sum of twenty-five dollars (\$25.00) per hour per officer. The charge can be prorated into fifteen minute increments.

3. Peddlers, Solicitors and Canvassers - License application and requirements

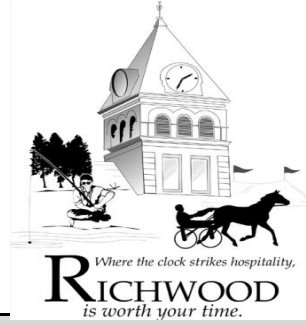
(a) Any person eighteen years of age and above shall pay a license <i>fee</i> . The <i>fee</i> shall be waived for all individuals under eighteen years of age.	\$30.00

Section 2: Water and Sewer fee schedule.

1. Water and Sewer Rates and Fees general costs

(a) Effective January 1, 2025. The base water rate shall increase by 2% over the existing \$24.96 per the first 2000 gallons of usage, with an additional 2% increase for each 1000 gallons of usage. The base water rate shall increase by 2% each year hereafter per the first 2000 gallons of usage, with an additional 2% increase for each 1000 gallons of usage.	
(b) In the case where more than a single residence and/or business is being served by one meter, the minimum charge to each user shall be the minimum monthly meter service multiplied by the number of units served or the calculated bill based on actual use, whichever is greater.	
(c) A minimum charge of \$25.00 will be charged for service if disconnection is at the property owner's request. If service is reconnected in the middle of the billing period then they will be billed for the actual usage.	
(d) The price to be charged for water furnished by the Village of Richwood to all customers situated outside the corporation limits of the Village:	
(1) 2000 gallons minimum charge	\$40.04 / month
(2) Over 2000 gallons	6.50 / 1000 gallons plus minimum charge

2. Water Reconnections.

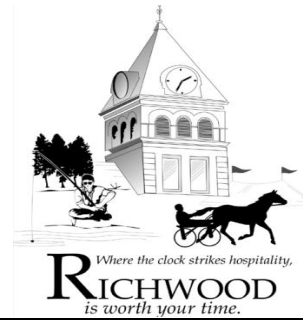
(a) If water service is disconnected due to nonpayment of the monthly bill, a reconnection fee plus the total delinquent balance shall be paid prior to the reconnection of water service.	\$50.00
(b) If water service is voluntarily terminated at the property owner's request, a reconnection fee shall be assessed.	\$25.00

3. Sewer Rates

(a) The following charges and fees are hereby adopted effective herewith as the bill charge and volume charge	
(1) Bill charge	\$10.30 per bill
(2) Volume charge	\$5.59 per bill
(3) Debt retirement	\$1.58 per bill
(4) Minimum monthly bill based on 2,000 gallon usage	\$20.48 per bill.
(5) Fee for each 1,000 gallons thereafter	\$4.16
(b) The price to be charged for sewer service furnished by the Village of Richwood to all customers situated outside of the corporation limits of the Village.	
(1) Minimum charge:	\$37.96 / month
(c) Charges for extra-strength wastes shall be as calculated in Section 925.06 . These rates shall be recalculated annually.

4. Tap fees, charges, and expenses

(a): Water tapping fee	
(1) ¾" Diameter	\$3,000.00
(2) 1" Diameter	\$5,250.00
(3) 1 1/2" Diameter	\$11,850.00
(4) 2" Diameter	\$14,000.00
(5) 3" Diameter	\$31,700.00
(6) 4" Diameter	\$56,000.00
(7) 6" Diameter	\$127,000.00
(8) 8" Diameter	\$227,300.00
(9) Water Inspection Fee	\$75.00

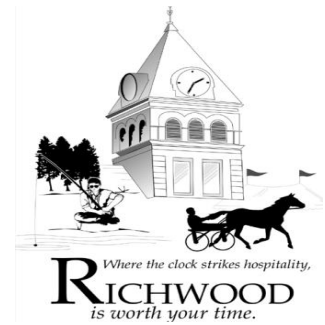
Note: When a service line is used for fire protection only, the water connection fees shall be reduced to thirty percent of the above rate. The service line for fire protection shall be separate from all other service lines. There shall not be any Connection between a fire protection system and water system for domestic use.

(b): Wastewater capacity fees (tap fee): the owner of any lot of plot of ground which is improved by building thereon is required by law to connect into the sewage system of the Village, must make application to the Administrator for the connection permit and shall pay a capacity fee. The capacity fee shall be \$10.00 per gallon of standard strength sewer discharged in on average day: the average daily gallon usage being determined by the following schedule. (the minimum capacity fee is \$4000.00)

(c) Schedule of average daily gallon usage:

(1) Single family dwelling, 1 family per bldg.	400
(2) Apartments one bedroom, two bedroom, three bedroom or more	250
(3) Assembly halls	2 / seat
(4) Bowling alleys: no food service	75 / lane
(5) Churches. Small	3-5 / sanctuary seat
(6) Churches, large with kitchen	5-7 / sanctuary seat
(7) Dance Halls	2 per person
(8) Drive - in theaters	5 per car space
(9) Factories and Warehouses, no showers	25 per employee
(10) Factories and Warehouses, with showers	35 per employee
(11) Food service operations: Ordinary restaurant, not 24 hour *note(a)	35 / seat at 400 ppm BOD
(12) 24 hour restaurant *note(a)	50 / seat at 400 ppm BOD
(13) Banquet rooms *note(a)	2 / seat at 400 ppm BOD
(14) Restaurant along freeway *note(a)	100 / seat at 400 ppm BOD
(15) Tavern, very little food service *note(a)	35 / seat at 400 ppm BOD
(16) Curb service, drive-in *note(a)	50 / space at 400 ppm BOD
(17) Vending machine restaurants *note(a)	100 / seat at 200 ppm BOD
(18) Hospitals, no resident personnel *note(a)	300 / bed
(19) Institutions, residents *note(a)	100 / person

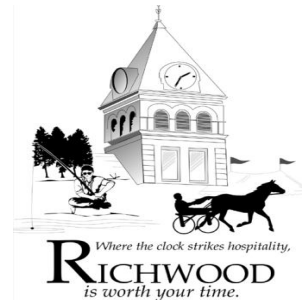

Note a: - Connection fees for 400ppm BOD sewage shall be doubled.	
Note b: - Truck parking areas will require consideration for treatment of run-off at large truck stops	
Note c: - The gallons per day that requires the largest treatment capacity shall be used to calculate the connection fee.	
Note d: Capacity Charge Credits. A credit will be given for a redevelopment property where a previous tap existed. The cost of the redevelopment credit will be based on the previous water meter size.
