AKRON TOWNSHIP ROAD CONSTRUCTION AND MAINTENANCE MILLAGE PROPOSAL (RENEWAL)

Shall the limitation of the amount of Property taxes which may be assessed Each year against property in the Township of Akron, County of Tuscola, State of Michigan, be renewed for a Period of five (5) years: 2026 through 2030 inclusive, up to 1.8730 mills on the Valuation of the taxable real and Personal property situated in the Township of Akron, County of Tuscola, State of Michigan, said millage to be used exclusively for ROAD CONSTRUCTION AND MAINTENANCE, as provided for by Section 6, Article IX of the 1963 Constitution of the State of Michigan This proposal will raise in the first year of the levy an estimated sum of \$273,366.00 and alike amount in subsequent years
