Ordinance Number 725-

An ordinance appropriating certain money's.

Be it ordained by the mayor and commissioners of the City of Garnett, Kansas,

Section One:- that the sum of *Four Hundred and Seventy and 22/100* Dollars be and the same is hereby appropriated out of the General fund in the hands of the city Treasurer to pay the bills allowed against said fund at a regular meeting of said Board held on the 3d day of December 1917 a list of which may be found on page _____ of the journal of the proceedings of the Board on said date.

Section Two:- that the sum of *Two Hundred and ninety Six and 78/100* Dollars be and the same is hereby appropriated out of the Water works Fund in the hands of the city Treasurer to pay the bills allowed against said fund at a regular meeting of said Board held on the 3d day of Dec, 1917 a list of which may be found on page _____ of the Journal of the proceedings of the Board on said date.

Section Three:- that the sum of *Five Hundred and Thirty and 45/100* Dollars be and the same is hereby appropriated out of the Electric Light Fund in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 3d day of Dec, 1917, a list of which may be found on page _____ of the Journal of the proceedings of the Board on said date.

Section ~~Three~~ *Four*:- that the sum of *One Hundred and Three and 20/100* Dollars be and the same is hereby appropriated out of the Street Fund in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 3d day of December 1917. a list of which may be found on page _____ of the Journal of the proceedings of the Board on said Date.

Section ~~Four~~ *Five*:- that the sum of *Two and 20/100* Dollars be and the same is hereby appropriated out of the Funds of Sewer District Number (1) in the hands of the city treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 3d day of december 1917. a list of which may be found on page _____ of the journal of the proceedings of the Board on said date.

Section ~~Five~~ *Six*:- that the sum of Seven Thousand Two Hundred & Sixty Nine & 82/100 ----- Dollars be and the same is hereby appropriated out of the Paving Tax Fund No, (7) in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 3d day of Dec, 1917. a list of which may be found on page _____ of the Journal of the proceedings of the Board on said date.

Section ~~Eight~~ ^{Eight} :- that the mayor and city clerk be and are hereby instructed and authorized to draw warrants on the city treasurer to pay the bills allowed in the forgoing sections of this ordinance.

Section ~~Nine~~ ^{Nine} :- that this ordinance shall take effect and be in force from and after its passage by the Board of Commissioners and its approval by the Mayor.
