RATES ARE UP

We are committed to improving the returns on your deposit balances in 2023. Share account interest rates will begin the year at 1% APY. We will continue to watch the Federal Reserve and will adjust our rates accordingly. All certificates of deposit will begin the year at 3% APY for 1- to 3-year terms. IRA rates will also begin the year at 1% APY. Your money on deposit at the credit union has more power in 2023.

Also, in March (as part of our anniversary specials) we will be launching our City Saver Program. The program, for those who meet the qualifications, will have interest rates as high as 2.75% APY.

BOARD ELECTION NOTICE

There are four board positions to be filled at the annual meeting on March 7, 2023.

The nominating committee has submitted the names of Hector Mendoza and Lanitra Barringer to fill two seats. The nominating committee will continue to seek candidates for the two additional seats; we are especially interested in persons who can contribute to our community development efforts. If you are interested, please contact CEO Frank Frazzitta. In addition to names submitted by the nominating committee, credit union bylaws provide for nomination from the membership. A petition signed by at least 35 members may submit other names.

The deadline for filing a petition with the credit union secretary is January 31, 2023. If petitions are received that result in more than one nominee for each position to be filled, ballots will be distributed to eligible voters attending the annual meeting on March 3, 2023.

Election shall then be determined by plurality vote. If no petitions are received and there is only one nominee for each position to be filled, those nominated shall be elected by general consent of acclamation. Nomination from the floor at the annual meeting shall not be permitted.
